WHEREAS, During her career as a consultant, Lisa prepared numerous reports, studies and assessments for local water agencies including the city of Newport Beach, Orange County Sanitation District, West Basin Municipal Water District, Serrano Water District, Santa Ana Watershed Project Authority, and others; and

WHEREAS, Lisa leaves the East Orange County Water District with a well-run, financed and respected utilities department that includes a professional staff capable of continuing the successful operations of water and sewer services well into the future.

#### RESOLUTION NO. 21-12-158 HONORING KARL SECKEL FOR 40 YEARS OF SERVICE IN THE WATER INDUSTRY

WHEREAS, Karl Seckel's professional experience in the water industry spans over 40 years and began as a consultant for Boyle Engineering before he was hired to work at the Municipal Water District of Orange County; and

WHEREAS, Karl coordinates water supply planning and operations with the Municipal Water District of Orange County's 28 member agencies who have come to greatly value Karl's knowledge and recommendations; and

WHEREAS, Karl is an esteemed water expert in Orange County who has tirelessly worked to improve the water supply reliability for the residents of Orange County; and

WHEREAS, Karl has been elected to the Municipal Water District of Orange County Board, Division 4, where he will utilize his vast knowledge and expertise to advance policies and programs that provide a reliable, high-quality water supply for the ratepayers of Orange County; and

WHEREAS, Karl is a graduate of the University of Maryland and holds bachelor's and master's degrees in civil engineering. He is also a registered Professional Engineer in the State of California.

6. City of Newport Beach Request to Extend Term of Lease Agreement for Use of Seawater Intake Pipeline for Water Transmission Purposes

# RESOLUTION NO. 20-12-159 APPROVING RENEWED LEASE AGREEMENT WITH OF CITY OF NEWPORT BEACH LEASE FOR USE OF SEAWATER INTAKE PIPELINE FOR WATER TRANSMISSION PURPOSES

WHEREAS, OCWD owns a pipeline extending from Water Factory 21 to the Pacific Ocean in Huntington Beach, constructed for the former OCWD seawater desalting facility; and

WHEREAS, pursuant to Resolution No. R90-9-201 adopted September 19, 1990, OCWD approved execution of a 25-year Lease Agreement with City of Newport beach to utilize an unused portion of such seawater intake pipeline to convey groundwater from the City's wells in Fountain Valley to its water facilities in Newport Beach, for a fee of \$1.00 per year; and

WHEREAS, the Property Management Committee of this Board has recommended renewal of such lease for an additional 25 year-period through September 22, 2047, for a fee of \$1.00 per year;

NOW, THEREFORE, the Board of Directors of the Orange County Water District does hereby approve extension of the aforementioned lease agreement as outlined herein; and, upon approval as to form by District General Counsel, its execution by the District officers is authorized.

#### MATTER FOR CONSIDERATION

7. Contract No. GG-2020-1, Garden Grove Wells 19, 21, 23, 28, 29, and 30 PFAS Water Treatment Plants

Principal Engineer Ryan Bouley presented the Engineer's Report for the Garden Grove PFAS Water Treatment Plant Project which includes Wells No. 19, 21, 23, 28, 29 and 30. He stated that due to site constraints at the Garden Grove Wells sites, Ion Exchange (IX) treatment has been selected as the treatment method, noting that Well 19 will be excluded from the Project at this time pending further evaluation by City staff of the condition of the well during Fiscal Year 2021-22. He advised that review of the Garden Grove Wells treatment plants is underway at the State Division of Drinking Water (DDW) in preparation for issuance of an amendment to the City's Domestic Water Supply Permit. Mr. Bouley noted the total Project budget excluding construction of Well 19 is estimated at 26,207,000. The Board then took the following action.

#### **RESOLUTION NO. 20-12-160**

APPROVING ENGINEER'S REPORT FOR GARDEN GROVE PFAS WATER TREATMENT PLANTS (WELLS 19, 21, 23, 28, 29, AND 30), DETERMING PROJECT FEASIBLE NECESSARY AND BENEFICIAL TO THE LANDS OF THE DISRICT, AUTHORIZING FILING OF CATEGORICAL EXEMPTION, AUTHORIZING PUBLICATION OF RFP TO PROCURE AND INSTALL ION EXCHANGE RESIN MEDIA FOR PFAS TREATMENT PLANTS, AND AUTHORIZING PUBLICATION OF NOTICE INVITING BIDS FOR CONTRACT NO. GARDEN GROVE-2020-1, GARDEN GROVE WELLS 21, 23, 28, 29, AND 30 PFAS WATER TREATMENT PLANTS

WHEREAS, the District staff has presented and recommended approval of the Engineer's Report for the City of Garden Grove Wells 19, 21, 23, 28, 29, and 30 PFAS Water Treatment Plant Projects to evaluate the need, benefits, and cost of constructing a Per-and Polyfluoroalkyl Substances (PFAS) treatment systems for the aforementioned Garden Grove wells; and

WHEREAS, based upon the Conclusions and Recommendations reached in the aforementioned Engineer's Report, the District staff has recommended that the Board determine the PFAS Water Treatment Plants project feasible, necessary and beneficial to the lands of the District and declare the Project duly instituted; and

WHERAS, the proposed Treatment Plant Projects will consist of Garden Grove Wells Nos. 21, 23, 28, 29, and 30 and will include the design, permitting, construction, and operation of the PFAS removal systems for the Garden Grove Wells in accordance with the District PFAS policy to remove PFOA and PFOS to less than 2 ppt (the current non-detect limit); and

WHEREAS, Garden Grove Well No. 19 will be excluded from the Projects at this time pending further evaluation by City staff of the condition of the well during Fiscal Year 2021-2022; and

WHEREAS, due to the site constraints at the Garden Grove well sites, Ion Exchange treatment has been selected as the treatment method to ensure the groundwater supplied by the Garden Grove Wells can be served to the City in compliance with PFAS regulations; and

WHEREAS, staff has determined that the Garden Grove PFAS Treatment Plants project is consistent with the California Environmental Quality Act (CEQA) Categorical Exemption for New Construction or Conversion of Small Structures (Class 3) because it consists of the construction and operation of a limited number of new, small facilities or structures; and

WHEREAS, in this regard and in accordance with CEQA guidelines, the District staff has recommended filing of a Categorical Exemption for the Garden Grove Wells Nos. 19, 21, 23, 28, 29, and 30 PFAS Water Treatment Plants Project; and

WHEREAS, the District staff has recommended publication of a Request for Proposals to Procure and Install Ion Exchange Resin Media for Garden Grove Wells 21, 23, 28, 29 and 30; and

WHEREAS, the District staff has further recommended publication of a Notice Inviting Bids for construction of Contract No. GG-2020-1, Garden Grove Wells 21,23 28, 29, and 30 Water Treatment Plants;

NOW, THEREFORE, the Board of Directors of the Orange County Water District does hereby resolve as follows:

Section 1: The Engineer's Report for the Garden Grove Wells 19, 21, 23, 28, 29, 30, and 31 PFAS Water Treatment Plant Projects is approved and the Project is hereby determined feasible, necessary and beneficial to the lands of the District and is declared duly instituted.

<u>Section 2</u>: Filing of a Categorical Exemption is authorized for the Garden Grove Wells 19, 21, 23, 28, 29, 30, and 31 PFAS Water Treatment Plants project in compliance with CEQA guidelines.

<u>Section 3</u>: Publication of a Request for Proposals is authorized to Procure and Install Ion Exchange Resin Media for the Garden Grove Wells 21, 23, 28, 29, and 30 PFAS Treatment Plants; and

<u>Section 4</u>: Publication of a Notice Inviting Bids for Contract No. Garden Grove-2020-1, Garden Grove Wells 21, 23, 28, 29, and 30 PFAS Water Treatment Plants is authorized.

#### 8. Contract No. YLWD-2020-1, Yorba Linda Water District PFAS Water Treatment Plant:

Director of Engineering Chris Olsen presented the Engineer's Report for the Yorba Linda Water District PFAS Water Treatment Plant Project which includes 10 wells (1, 5, 7, 10, 12, 18, 19, 20, 21 and future 22) and is estimated to cost 24,200,000. He stated that due to site constraints at the YLWD Wells sites, Ion Exchange (IX) treatment has been selected as the treatment method, noting the number of vessels and required support systems needed for IX allows for less area to be occupied by the treatment plant than would be required for Granular Activated Carbon (GAC), Nanofiltration (NF), or Reverse Osmosis (RO). After discussion, the Board took the following action.

APPROVING ENGINEER'S REPORT FOR YORBA LINDA WATER DISTRICT PFAS WATER TREATMENT PLANT; DETERMING PROJECT FEASIBLE NECESSARY AND BENEFICIAL TO THE LANDS OF THE DISRICT, AUTHORIZING FILING OF CATEGORICAL EXEMPTION FOR PROJECT, AUTHORIZING PUBLICATION OF RFP TO PROCURE AND INSTALL ION EXCHANGE RESIN MEDIA, AND AUTHORIZING PUBLICATION OF NOTICE INVITING BIDS FOR CONTRACT NO. YLWD-2020-1, YLWD PFAS WATER TREATMENT PLANT

WHEREAS, the District staff has presented and recommended approval of the Engineer's Report for the Yorba Linda Water District (YLWD) Water Treatment Plant to evaluate the need, benefits, and cost of constructing a Per- and Polyfluoroalkyl Substances (PFAS) treatment system for YLWD's production wells, namely, Wells No. 1, 5, 7, 10, 12, 18, 19, 20, 21 and future 22 specifically to remove perfluorooctanoic acid (PFOA) and perfluorooctane sulfonate (PFOS); and

WHERAS, based upon the Conclusions and Recommendations reached in such Engineer's Report, the District staff has recommended that the Board determine the YLWD PFAS Water Treatment Plant project feasible, necessary and beneficial to the lands of the District and declare the Project duly instituted; and

WHEREAS, due to the site constraints at the YLWD well sites, Ion Exchange treatment has been selected as the treatment method to ensure the groundwater supplied by YLWD can be served to the City in compliance with PFAS regulations; and

WHEREAS, staff has determined that the YLWD project is consistent with the California Environmental Quality Act (CEQA) Categorical Exemption for New Construction or Conversion of Small Structures (Class 3) because it consists of the construction and operation of a limited number of new, small facilities or structures; and

WHEREAS, in this regard and in accordance with CEQA guidelines, the District staff has recommended filing of a Categorical Exemption for the aforementioned 10 YLWD Wells included PFAS Water Treatment Plant Project; and

WHEREAS, the District staff has recommended publication of a Request for Proposals to Procure and Install Ion Exchange Resin Media for the YLWD PFAS Water Treatment Plant Project;

NOW, THEREFORE, the Board of Directors of the Orange County Water District does hereby resolve as follows:

<u>Section 1</u>: The Engineer's Report for the YLWD PFAS Water Treatment Plant Project is approved and the Project is hereby determined feasible, necessary and beneficial to the lands of the District and such project is declared duly instituted.

<u>Section 2</u>: Filing of a Categorical Exemption is authorized for the YLWD PFAS Water Treatment Plant Project as outlined herein in compliance with CEQA guidelines.

<u>Section 3</u>: Publication of a Request for Proposals is authorized to Procure and Install Ion Exchange Resin Media for the YLWD PFAS Water Treatment Plant Project.

<u>Section 4</u>: Publication of a Notice Inviting Bids for Contract No. YLWD-2020-1, PFAS Water Treatment Plant, is authorized.

#### 9. PFAS Update

Health and Regulatory Director Jason Dadakis updated the Board on recent PFAS regulatory activities noting that all required monitoring testing for the Groundwater Producers (GWP) for the current 4<sup>th</sup> quarter of 2020 is complete. He stated staff is following up with GWP's with new detections. Mr. Dadakis reported that staff has been advised to anticipate an additional set of statewide monitoring orders from the Division of Drinking Water for facilities in close proximity to Department of Defense facilities and that GWPs should anticipate receiving these new orders within the next month or two with the first required monitoring in the second quarter of 2021. Mr. Dadakis stated that the State has not provided an update on the status of the draft public health goals for PFOA and PFAS.

#### 10. Santa Ana Watershed Project Authorities Activities

Director Rowe reported on the December 1 SAWPA Commission meeting and advised that SAWPA is considering including siting for cloud seeding generators in next year's budget.

#### 11. Committee/Conference/Meeting Reports

The Board reported on attendance at the November 20 Property Management Committee meeting, noting the Action Agenda was included in tonight's Board packet.
