1	Are there any existing geotechnical reports at the location of the GAP Reservoir? If yes, when can they be made available?	OCWD is not in possession of the geotechnical report. As part of the records review, please contact City of Santa Ana to request this report.
2	The RFP mentions that OCWD will not be providing any safety equipment. Can OCWD provide electricity for safety equipment such as lights and fans?	During lock out tag out procedures at the pump station, electrical circuits at or near the reservoir may be powered off. Please plan on mobilizing a generator to power light, fans, or other equipment.
