#### 6. SAWPA/City of Riverside Housing Authority Proposed MOU on Homelessness

Executive Director Greg Woodside stated that the Santa Ana Watershed Project Authority (SAWPA) Commission at its May 15 meeting will consider approval of a Memorandum of Understanding (MOU) regarding homelessness with the City of Riverside's Housing Authority. He stated OCWD staff believes a water quality study should be conducted to assess if there are significant negative impacts to water quality from homeless encampments adjacent to the Santa Ana River prior to additional expenditure of SAWPA funds or state grant funds related to addressing homelessness. He requested that consideration of the MOU should be deferred until such study is completed. SAWPA General Manager Rich Haller stated that the proposed MOU will develop answers and data to address OCWD staff concerns. Orange County Coastkeeper representative Ray Hiemstra stated that there is a need to work on homelessness issues due to its effect on water quality and urged the Board to support and expedite the proposed MOU. Staff was directed to schedule a future OCWD board workshop regarding Disadvantaged Community programs and funding sources that SAWPA is administering.

- 2) Consideration of the MOU should be deferred until after the water quality study is completed; and
- 3) If there is a water quality issue related to homelessness encampments adjacent to the Santa Ana River OCWD, would participate in determining appropriate follow-up actions.
