1. Minutes of Previous Meeting

The minutes of the GWRS Steering Committee meeting held April 10, 2023, are approved as presented.

**INFORMATIONAL ITEMS**

2. GWRS Operations Update

Executive Director of Operations/GWRS Mehul Patel reported that the Fiscal Year ended June 30, 2023, and the final FY2022-2023 production was 101, 981 AF. He stated that the original goal for the year was 110,000 AF based on the assumption that the final expansion would be done in the first 6 months of the fiscal year and the second half of the fiscal year, there would be the availability to make 130 MGD per day. He highlighted activities that arose to limit production during the Second Quarter. He noted recent heavy precipitation from the winter resulted in limited recharge basin capacity and various maintenance work by OC San and planned outages to work on equipment. He stated production was up to 115 mgd by June, with production being limited to 115-120 mgd until RO pump issues are resolved by the GWRSFE contractor.

3. GWRS Second Quarter Outreach Report (April – June)

Director of Public Affairs Gina Ayala reported the success of the GWRS Final Completion dedication held on April 14. She reported that we had 14 speakers, and the event was attended by over 300 attendees comprising elected officials, members of the water industry, regulators, and producers. The event attracted much media attention both onsite and post-event. She reported onsite coverage, including ABC7, OC Register, Orange Coast Magazine, LA Times, and Spectrum News. She announced that GWRS received four awards during the second quarter and expressed our continued collaboration with OC San to pursue further awards. She shared PBS aired a special program titled "Weathering the Future" that highlighted GWRS, which has had over a million viewers. As a result of the show, PBS approached OCWD to do a virtual field trip that reached over 2,000 students across the US. She noted that we continue to hold in-person and online tours.
