8. Proposed FY 2025-26 General Fund Budget

CFO/Treasurer Randy Fick reported that the proposed FY 2025-26 General Fund Budget totals \$114.8 million, a \$4.2 million increase from the current FY 2024-25 budget. He advised that the increase is primarily due to two costs: 1) a \$2.1 million increase in wages and benefits due to 4.5% cost-of-living adjustment and 3% merit based on the employee's performance, and 2) \$1.1 million increase for sediment removal behind Prado Dam. He stated the General Fund covers 21 Cost Center that includes salaries, supplies and services.

9. Monthly Cash Disbursements Report

There was no discussion of this item.

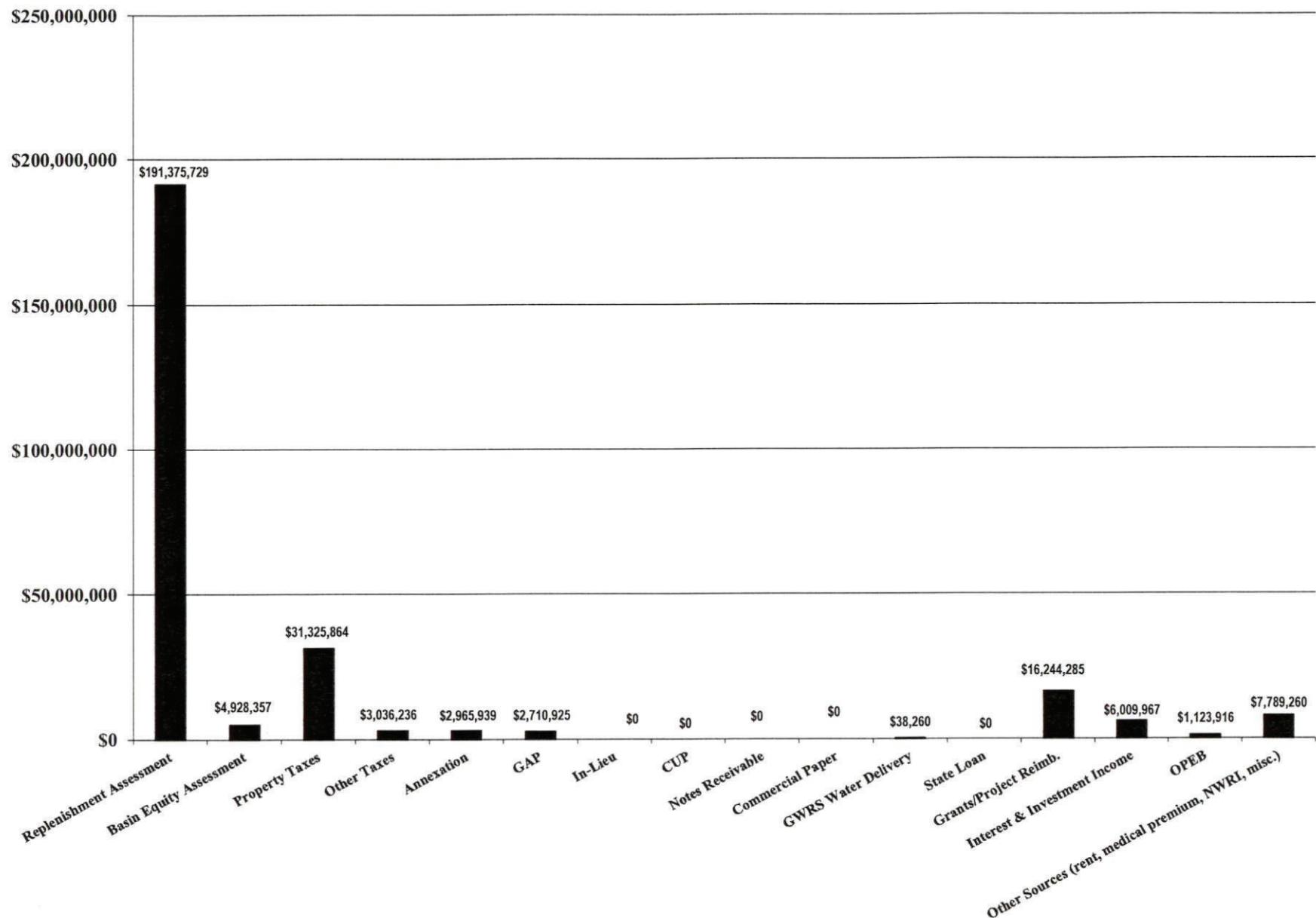

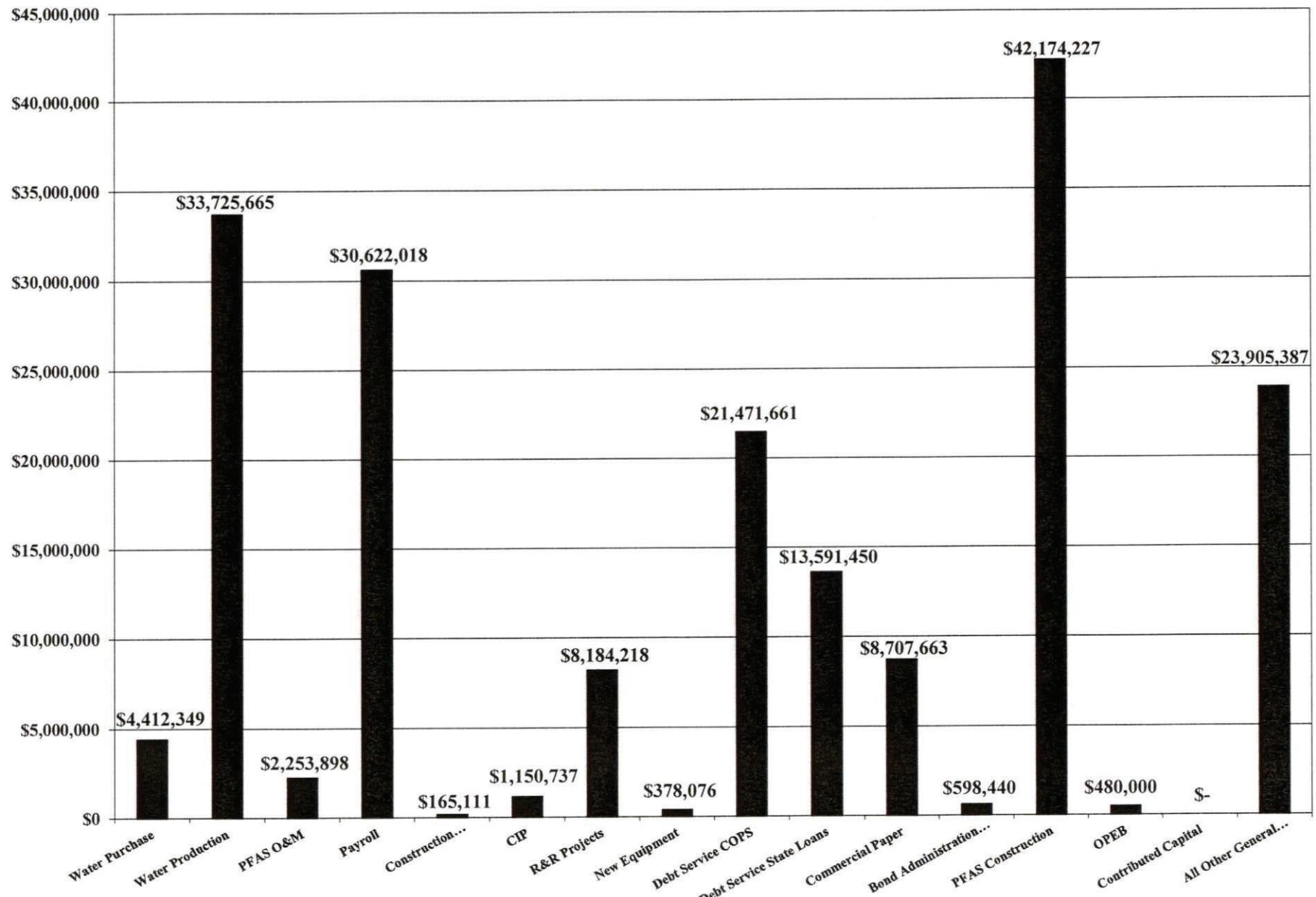

BACKGROUND/ANALYSIS

The Investment Portfolio Holdings Report is a list of each of the District's fixed income investments and provides the market value at the end of each month. All securities within the District's Investment Portfolio are in compliance with the District's Statement of Investment Policy. The District's portfolio maturities provide cash liquidity sufficient to meet the District's projected six-month expenditures (as required by Government Code Section 53646).

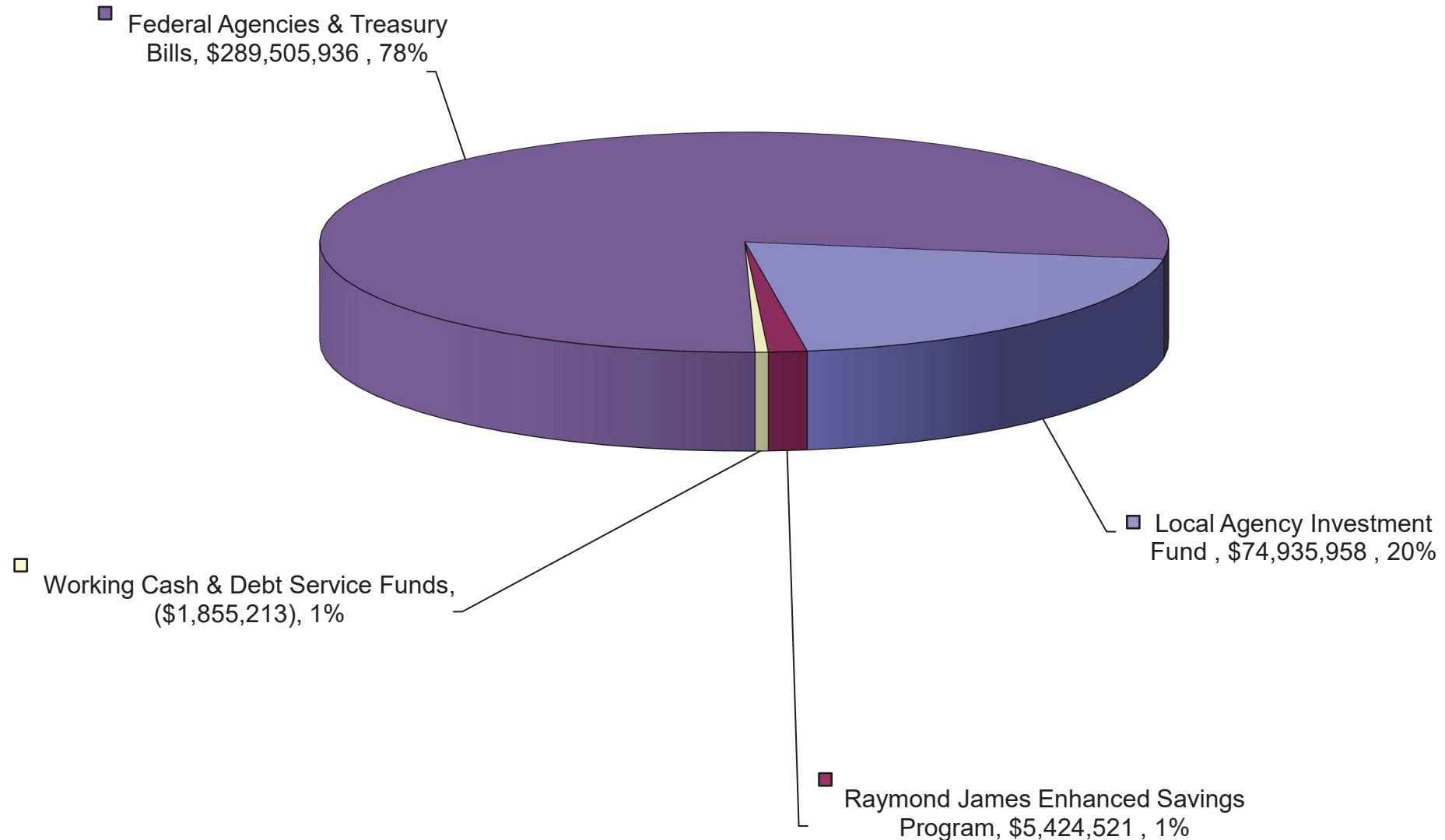
- The yield on the one-year Treasury note as of the month end is at 3.85%; two-year at 3.60% and the five-year at 3.72%. The last Federal Open Market committee (FOMC) meeting was held on March 18-19, 2025. The FOMC maintained the Federal fund benchmark interest rate to a range of 4.25% to 4.50%. 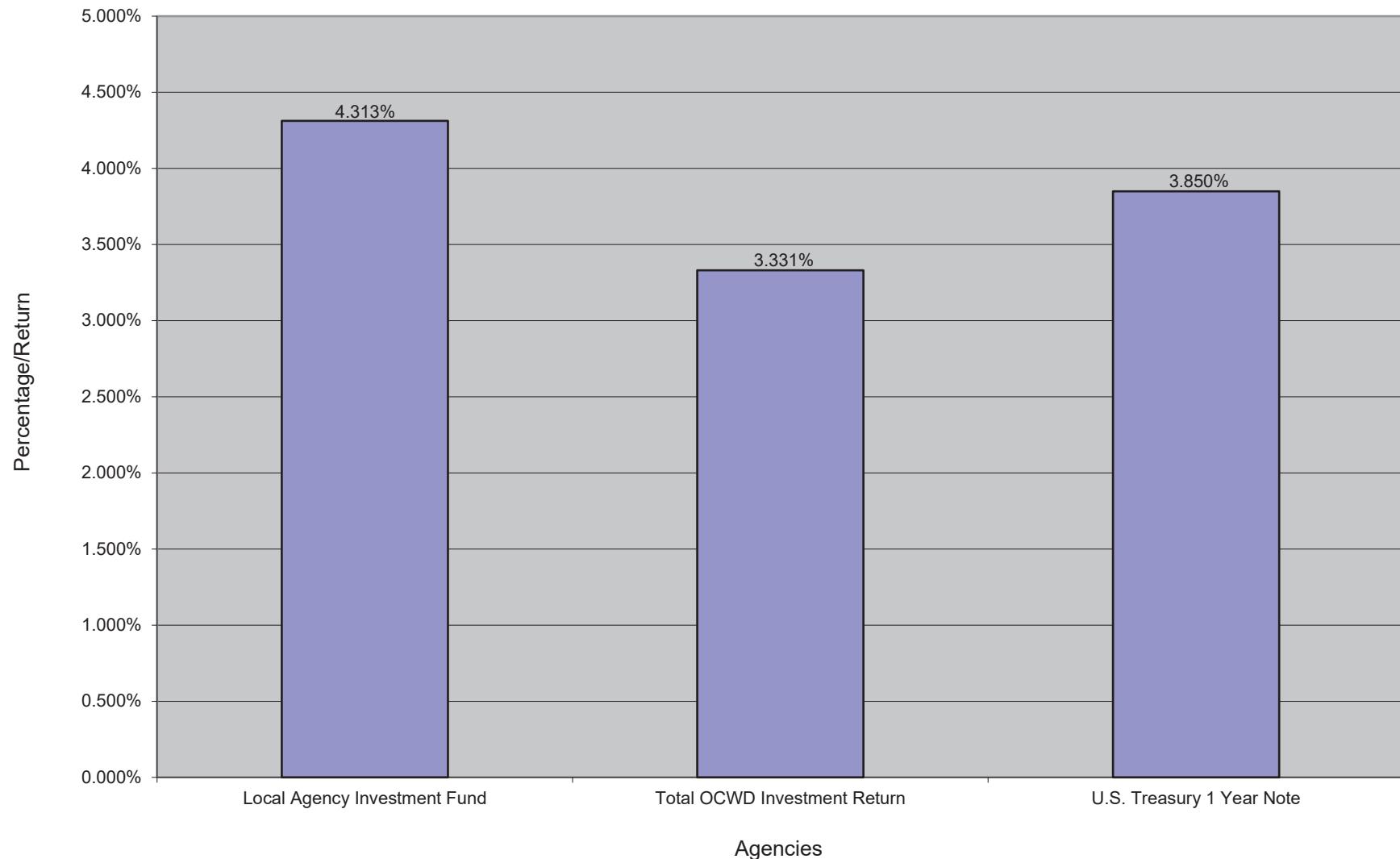

OCWD - Investment Portfolio as of April 30, 2025

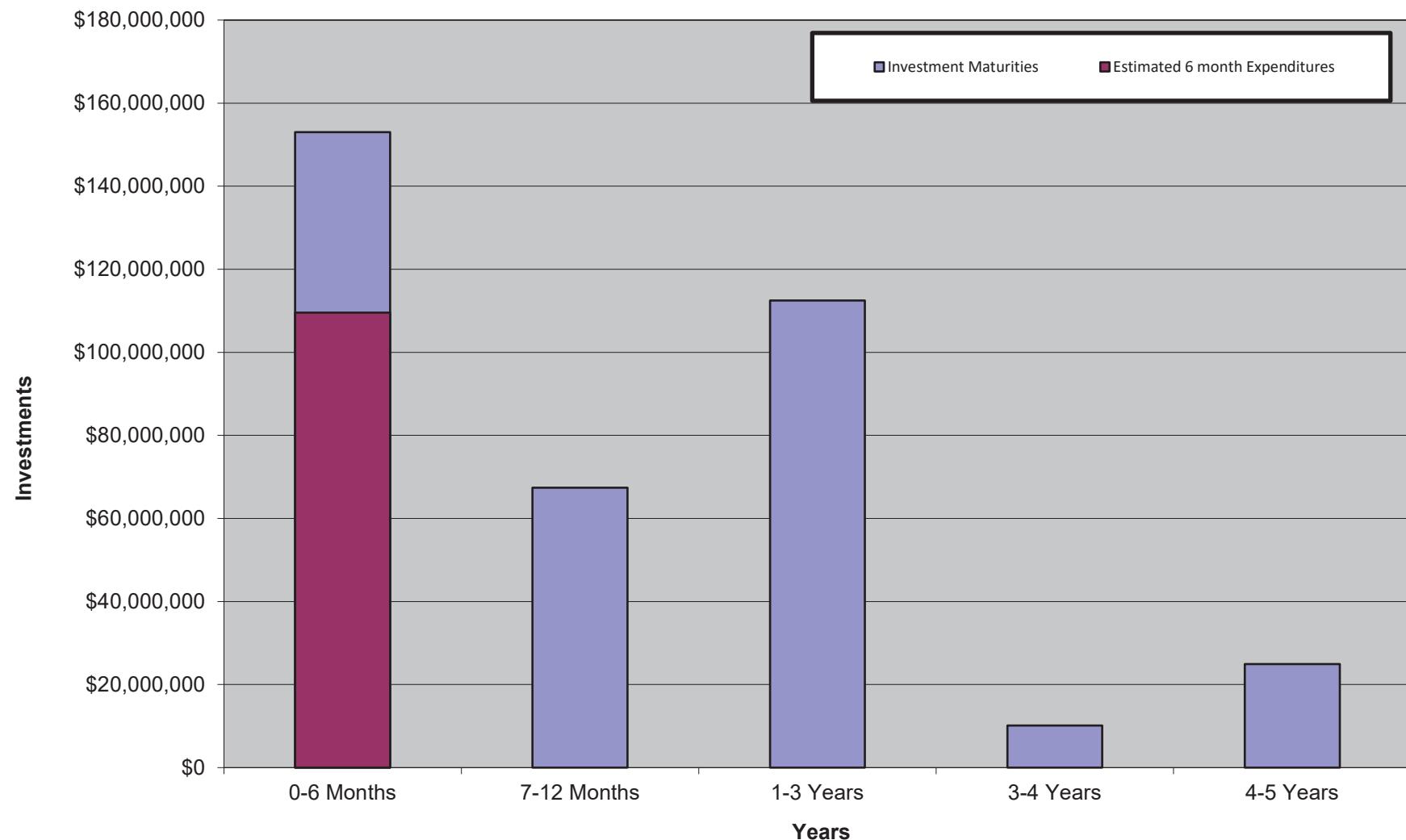


OCWD - Investment Return Comparison for the Month Ended 04/30/25

Subject: ULTRAVIOLET LIGHT (UV) EQUIPMENT SUPPLY

SUMMARY

The District previously selected Trojan Technologies for the UV system for the Groundwater Replenishment System. Trojan Technologies was selected from four pre-qualified equipment manufacturers to supply the equipment for the permanent UV system. Staff recommends purchasing UV lamps for restocking inventory.

Attachment: Quotation for the purchase of UV lamps dated April 28, 2025, in the total amount of \$272,691. (Freight of \$1,734 is included in this quote.)

RECOMMENDATION

Agendize for May 21 Board meeting: Authorize issuance of Purchase Order to Trojan Technologies Corp for the purchase of 1,080 UV lamps in the amount of \$272,691, including freight.

BACKGROUND/ANALYSIS

In 2002, the Board of Directors for OCWD and OCSD authorized OCWD to award a pre-selection agreement to Trojan Technologies for the manufacture of ultraviolet light equipment for the Groundwater Replenishment System. The basis of pre-selection was the lowest present worth life-cycle cost. This type of present worth analysis includes all capital, as well as O&M costs, over the 25 years chosen for the analysis.

Requests for Proposals were issued to four pre-qualified UV equipment manufacturers. Two responses were received, one of which was Trojan. Trojan had the lowest calculated present worth life cycle cost and the lowest capital cost of the UV equipment for their UVPHox system. Trojan has been supplying UV lamps for the Groundwater Replenishment System since the system was first put online in 2008. The lamps are now purchased directly through Trojan. Purchasing UV lamps from other manufacturers is prohibited per the Pre-Selection Agreement approved in 2002. In addition, the Regional Water Quality Control Board operating permit for GWRS was based upon the use of UV lamps supplied by Trojan Technologies. The GWRS UVPHox system

pathogen removal credits granted by the Division of Drinking Water were validated and approved based on the use of Trojan-supplied UV lamps. The use of another manufacturer's UV lamp would require at a minimum a re-validation of the UVPhox system and a possible operating permit amendment. In addition, minimum required contaminant removals are guaranteed by Trojan with the use of Trojan-supplied UV lamps.

The budget for the procurement of UV lamps is \$750,000. Due to the importance of having sufficient UV lamps, staff recommends replenishing the inventory stock with an extra order of lamps, or approval to purchase 1,080 lamps at this time. Staff will be coming back to the board as needed during the fiscal year to approve additional purchases each time lamp inventory requires replenishment.

Subject: **AMENDMENT 6 TO AGREEMENT 1315 WITH VALLEY CITIES/GONZALES FENCE, INC., FOR ON-CALL FENCE REPAIRS**

SUMMARY

Valley Cities/Gonzales Fence, Inc., has provided excellent on-call fence repair for the past seven years and has agreed to maintain the fence repairs at the same price over the next two years. Staff recommends extending the existing agreement for two years.

RECOMMENDATION

Agendize for May 21 Board meeting: Authorize issuance of Amendment No. 6 to Agreement No. 1315 with Valley Cities/Gonzales Fence, Inc. to extend the termination date to June 30, 2027, and increase the not-to-exceed amount by \$60,000.

BACKGROUND/ANALYSIS

Fencing contractors and District staff provide fence repairs and replacements throughout District property. District staff perform minor repairs, while contractors are used to perform larger scopes of work. Fences are frequently damaged by vandals who cut the fence to enter District property, vehicle drivers, vegetation growth, and dilapidated conditions due to fence age and environmental conditions. Fences are required to properly secure District property.

Agreement 1315 was executed with Valley Cities/Gonzales Fence, Inc. (Valley) in 2018 for on-call fence replacement and repairs. The agreement has previously been amended 5 times to extend the agreement duration and increase the authorized amount. Valley has kept their rates constant without increases for each amendment over the seven-year span. Holding the rates constant for seven years is a notable cost savings to the District. Staff recommends issuing Amendment No. 6 to extend the duration of Agreement 1315 for an additional two years (through June 30, 2027) with a total increase of \$60,000 (\$30,000 per fiscal year). This proposed Amendment 6 increase would increase the total not-to-exceed amount of Agreement 1315 to \$225,000.

Subject: AUTHORIZE AMENDMENT NO 1 TO AGREEMENT 1554 WITH YORKE ENGINEERING, INC FOR MOBILE SOURCE COMPLIANCE ASSISTANCE

SUMMARY

The District is required to comply with various fleet and equipment (mobile source) regulations that concern pollution technologies and controls. Staff has utilized Yorke Engineering for assistance with this issue and recommends an amendment to extend the agreement.

RECOMMENDATION

Agendize for May 21 Board meeting: Authorize Amendment No. 1 to Agreement 1554 with Yorke Engineering, Inc. for mobile source compliance assistance for an amount not to exceed \$20,000.

BACKGROUND/ANALYSIS

The District's on-road fleet, off-road fleet, forklifts, and portable equipment are subject to regulations from the California Air Resources Board (CARB), including its local South Coast Air Quality Management District (SCAQMD). Compliance programs include:

- Advanced Clean Fleet (ACF)
- Clean Truck Check (CTC)
- Large Spark-Ignition Engine (LSI)
- Off-Road Diesel-Fueled Fleets (ORD)
- Portable Equipment Registration Program (PERP), and
- Local rules issued by SCAQMD

Over the past decade, the quantity of programs, the technical complexity of the regulations, and the overlapping impacts of the programs have greatly increased. Under the General Manager's signing authority, a mobile source compliance consultant, Yorke Engineering, was hired in 2022 to help staff to better understand the programs, confirm compliance and reporting requirements, and to help staff plan for future asset management to keep the District in compliance.

In addition to regulatory compliance, there are occasional funding opportunities available to replace vehicles and equipment that require the use of an outside consultant due to technical complexities in the application process. One of the opportunities is called the Carl Moyer Memorial Air Quality Standards Attainment Program. This specific program encourages improvement of pollution controls before the improvements are required by regulation. Staff have reviewed guidance for the current round of Carl Moyer funding and believe that several vehicles and equipment pieces budgeted for replacement in fiscal year 2025-26 may be eligible for grants. Yorke Engineering will assist staff to apply for these grant opportunities.

Staff recommends authorization of Amendment No. 1 to Agreement 1554 with York Engineering for an amount not to exceed \$20,000 for Mobile Source Compliance Assistance to be performed at the direction of District staff. This amendment would bring the total agreement amount to \$40,000.

Subject: **AWARD OF SERVICES AGREEMENT FOR HABITAT RESTORATION SERVICES AT PRADO AND ORANGE COUNTY FACILITIES**

SUMMARY

The District has previously contracted with Habitat West to provide habitat restoration and maintenance services under two separate agreements for mitigation sites within Prado Basin and the Orange County recharge facilities, the first of which expires on June 30, 2025. On March 20, 2025, a Request for Proposals (RFP) for both sites was issued, to which the District received five responses. Staff has evaluated the proposals and recommends award of the work to Habitat West.

Attachment: Habitat West Proposal dated April 21, 2025.

RECOMMENDATION

Agendize for May 21 Board meeting: Authorize issuance of agreement to Habitat West for \$90,000, plus an additional \$180,000 per year starting in year 2, plus a 5% inflation rate for each subsequent year, for a not to exceed total of \$652,725 for three years.

BACKGROUND/ANALYSIS

The District has been required by the California Department of Fish and Wildlife (CDFW), the United States Fish and Wildlife Service (USFWS), and the United States Army Corps of Engineers (USACE) to plant native habitat as mitigation for the impact of District operations behind Prado Dam, including the operations of the Prado Wetlands and stormwater storage. To meet these requirements, OCWD has planted 942 acres of native habitat within Prado Basin. Additionally, CDFW and USACE have required mitigation for impacts of the Orange County recharge facilities as an obligation of the District's operation and maintenance permits. To meet these requirements, OCWD has planted 36 acres of native habitat.

While the District's CDFW permits are currently up for renewal and mitigation requirements are actively being negotiated, the USACE permit for operation of the Prado Wetlands contains an ongoing mitigation requirement of 2 acres of habitat restoration per year. Additionally, all mitigation sites must be monitored for five years to ensure they meet performance standards laid out in the District's mitigation plan.

Currently, mitigation sites at Prado, Santiago Basin, Burris Basin, and Huckleberry Basin are within their 5-year monitoring and maintenance period.

Habitat restoration services have previously been covered under two Agreements – one covering mitigation sites within Prado, and one covering mitigation sites in Orange County. The Prado Agreement (Agreement No. 1125) is set to expire on June 30, 2025. The Orange County Agreement (Agreement No. 1864) is set to expire on June 30, 2026.

On March 20, 2025, the District released an RFP for Habitat Restoration and Maintenance Services. The RFP was advertised on the District's website and sent to a list of landscape contractors who provide habitat restoration and maintenance services. The District received five (5) Statement of Qualifications (SOQs) from Habitat West, Natures Image, Dudek, Chambers Group, and IO Environmental & Infrastructure. The SOQ was evaluated by a selection committee consisting of three District staff and was evaluated based on qualifications, record of past performance on similar or related projects, and total cost that must comply with the Department of Industrial Relations (DIR) prevailing wage rates.

Based on the results from the SOQ evaluation, Habitat West was ranked the highest as the firm that demonstrated the most relevant experience and understanding of the scope of services within the RFQ and provided the best overall value for services.

The expenditures for FY 25-26 are not expected to exceed the \$180,000 currently budgeted for this service. In year two, the Orange County facilities will be included in the scope, increasing the cost to \$270,000 per year plus a 5% inflation rate. Staff anticipate a similar effort for year three, plus a 5% inflation rate.

Staff recommends award of a Service Agreement to Habitat West for habitat restoration and maintenance services within Prado Basin for an amount of \$90,000 for year one,

increased to \$274,500 for year two, and \$288,225 for year three, not to exceed \$652,725 for three years with an option to renew for an additional year with General Manager approval under the same terms and conditions. The expense for this multi-year scope of services is included in the Natural Resources Department general fund budget each fiscal year.

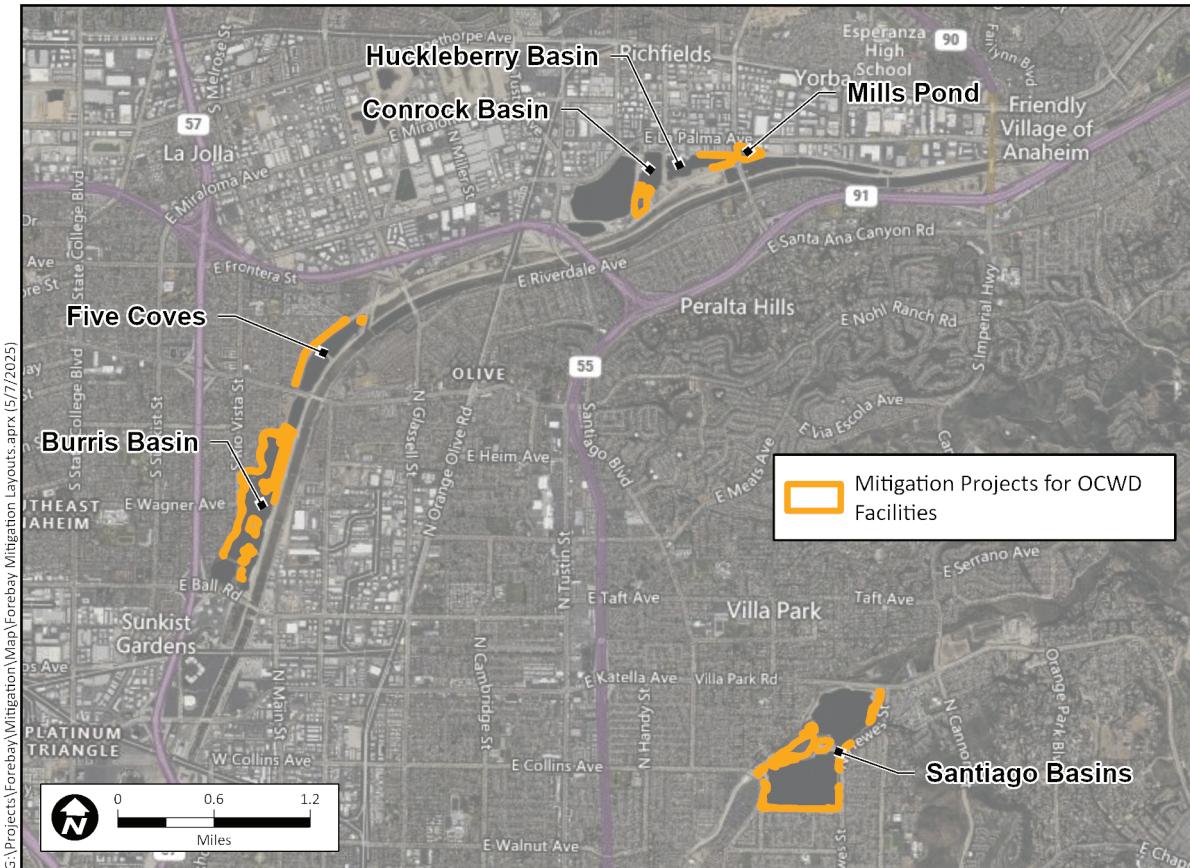

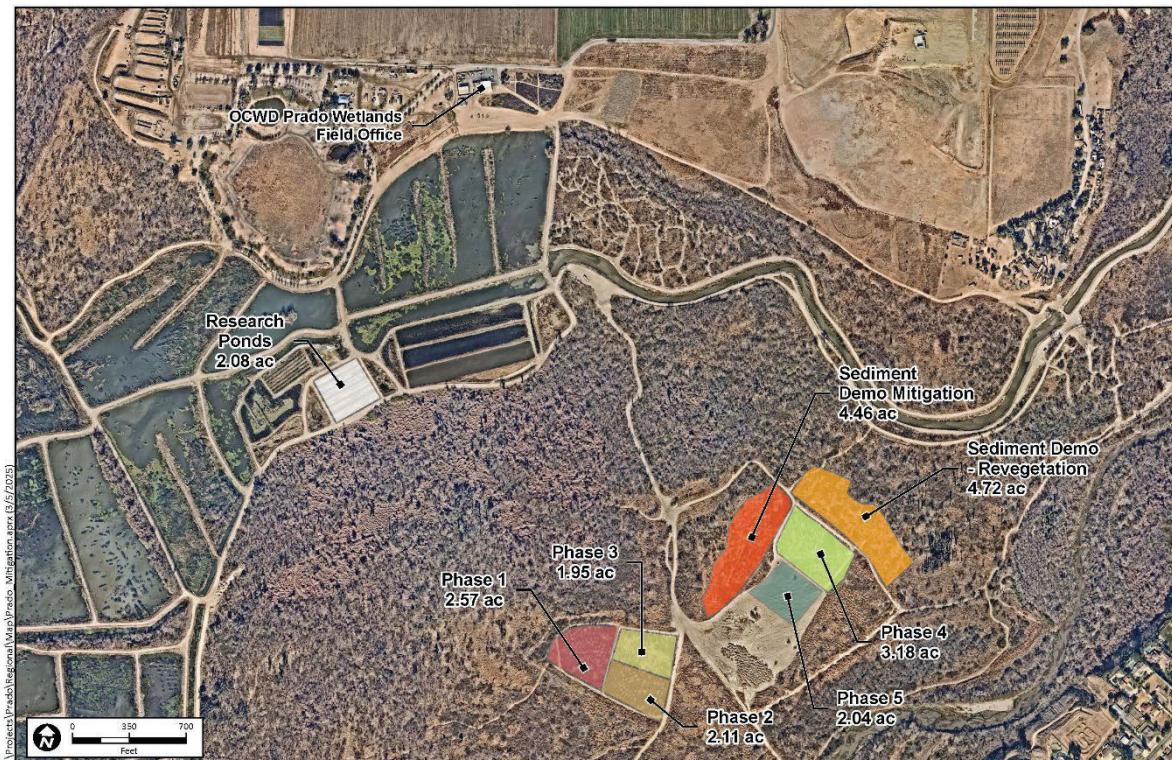

QUALIFIED PERSONNEL & LABOR FORCE

All Habitat West personnel receive on-the-job training to identify native and non-native plants. They are knowledgeable about native plants and invasive weed species, and are experienced in the installation and maintenance of native habitats. Our team leaders and labor crews are also trained to identify threatened and endangered birds, such as California Gnatcatcher, Least Bell's Vireo and Least Tern. Our crews are familiar with different types of bird calls, as well as their nesting habits. Before our crews enter a new working area, scouts are sent out ahead of the crew to locate any bird nests that may be present. If a nest is found, a safe buffer is established so as not to disturb it during maintenance activities.

EXHIBIT A:

APPROACH TO THE SCOPE OF WORK

Initially, Habitat West will generate a year-long maintenance schedule for all sites and will perform maintenance activities based on the results of regular maintenance monitoring visits conducted by Habitat West and discussed with OCWD staff. At the beginning of each month, our Project Manager will provide the Principal Environmental Specialist with a monthly schedule showing the days that work will be performed on each jobsite, and the type of work to be performed, subject to OCWD review.

Our Project Manager will regularly visit the sites, as he does for the current contract. He will report back to OCWD staff the areas that need attention, in order of urgency. Following approval, Habitat West will dispatch a crew of 4-10 men and whatever equipment is required for the tasks to be completed. Maintenance weeding, irrigation checks and repairs will be conducted monthly, or as determined by Habitat West and the OCWD staff. All sites will be monitored using a proactive approach utilizing the most efficient adaptive management techniques to maintain the health of the native vegetation.

The primary effort of the maintenance program is to control weeds, ensure maximum plant growth and augment or replace lost specimens thus creating a natural system that can support itself with little or no maintenance. The restoration sites will be monitored by Jim Corbett two times per month. General observations, such as health of planted species and signs of drought stress will be noted on a monthly report. In addition, restoration plantings will be examined to visually estimate percentage of cover, species mortality, species composition along with soil, weed and pest problems and will be included in the monthly report.

During maintenance visits, our supervisors and foremen are trained to check for problem areas. Habitat West's maintenance activities will focus on non-native weed removal, plant growth vigor, any exclusionary fencing, vandalism control and trash removal. Our weed control methods shall include hand removal, herbicide application, string trimming, and cutting or mowing as deemed appropriate. Our crews are highly trained to identify between native and non-native plant species, therefore only non-native invasive plant material and weeds will be removed. Erosion control measures that are in place will be monitored. Trash will be removed as needed. Habitat West will be vigilant in monitoring herbivore activity and taking measures to prevent damage and protect native plants on the site. We will encourage plant growth and establishment with the ultimate goal of creating a habitat that can sustain itself without irrigation.

PROACTIVE APPROACH & ADAPTIVE MANAGEMENT

Our project management approach is to stay ahead of the needs of the sites and tackle problems before they become too large or costly to manage. Our goal will be to reduce the seed bank of non-native weeds by removing them before they go to seed. By constantly evaluating all

sites in the scope of the contract, we identify which areas need attention, and resolve issues in order of priority. This proactive approach will provide the best outcome for the native habitats, and will provide OCWD with long term cost savings.

Habitat West has the ability to adapt our methods depending on the ever-changing dynamics affecting the project. These dynamics include, but are not limited to: seasonal changes, soil conditions, weed infestation, wildlife presence, and weather conditions. We draw on our 32 years of experience to help us adapt to these unpredictable elements. Our team leaders are always innovating new methods to solve challenges that arise. demonstrated in previous contracts for these sites. All targeted weeds noted will be controlled to assure weed coverage on all sites remains low to none at any given time. Methods that may be utilized include, but are not limited to:

- Weed removal by hand, using tools such as hoes and hand picks
- String trimming
- Mowing
- Soil solarization
- Organic herbicide application
- Conventional herbicide application

Our Project Manager holds a Qualified Applicators License (QAL) issued by the State of California Department of Pesticide Regulations. In addition, Gigi Hurst, Habitat Specialist, holds a Pest Control Advisers License (PCA) and a QAL. Each Habitat West herbicide applicator must complete a Pesticide Workers Training Program once per year. These PCA and QAL licenses, along with the Pesticide Worker Training Program enable us to:

- Know what pest management methods are available
- Evaluate the benefits and risk of each method
- Select methods that are most effective and least harmful to people and the environment
- Integrate several methods whenever possible
- Use pest control methods properly
- Observe local, state, and federal regulations
- Evaluate the success of our pest management efforts

ORGANIC ALTERNATIVES TO GLYPHOSATE

If requested by OCWD, treatment of non-native vegetation will be conducted with organic herbicides. Synthetic herbicides (e.g., glyphosate, etc.) would not be used without considering the effectiveness and cost efficiency of other measures first, such as hand weeding, thermal weed removal, or soil solarization. Before applying any type of herbicide, we will obtain permission from OCWD.

With Habitat West's participation and sponsorship for organizations such as Cal-IPC and SERCAL, we stay on the cutting edge of non-chemical alternatives for weed control. We are always up to date with new methodologies that are being field-tested.

EROSION CONTROL

If requested, Habitat West can provide erosion control and installation for any of the service sites, as well as any new planting sites within the OCWD scope of work. As part of our Best

Management Practices (BMP's), we will routinely inspect, clean, and maintain existing devices. We will implement and install new BMP's to prevent movement of sediments into wetlands or offsite locations.

REMEDIAL PLANTING

As required, the need for remedial planting or seeding will be identified during maintenance activities and noted in the monthly reports generated by our Project Manager. These reports will be presented to OCWD Principal Environmental Specialist, David McMichael. Habitat West will provide all necessary labor and equipment to perform remedial planting or soil amending if requested for these sites. Our experienced crews are trained in the installation of native plants and all our planting projects are implemented with the highest quality of industry standards with hands on supervision.

IRRIGATION

Habitat West is thoroughly familiar with the various irrigation systems at all OCWD Basin sites. Our crews have designed and installed most of the irrigation systems in operation and have maintained them since installation. Mr. Corbett, along with his two foremen Jorge Torres and Ramon Camacho, adjust irrigation schedules to optimize plant health while factoring seasonal weather changes. If any supplemental irrigation work is needed in the future, we have the ability to make suggestions on how these systems can be modified to meet the needs of additional planting. Habitat West's team of irrigation technicians are more than capable of installing and maintaining a sound and efficient irrigation system for any area requested.

TRASH AND DEBRIS REMOVAL

With Habitat West, the OCWD Basin Maintenance Sites will be maintained in a trash-free state at all times. Trash and debris removal will occur during regular maintenance activities. All trash collected from sites will be hauled to the county landfill or designated OCWD collection site.

VANDALISM AND TRESPASSING

Habitat West will report any vandalism or trespassing to the OCWD Project Manager within 24 hours. Our crews will repair any damage to native habitat caused by vandalism with the direction of OCWD Project Manager.

COMMUNICATION

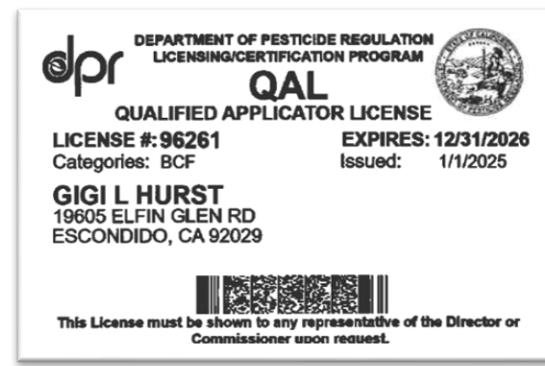
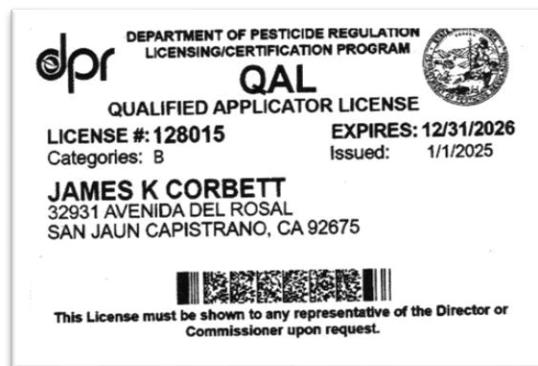
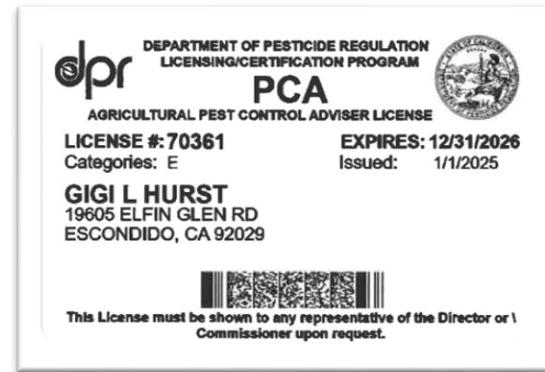

We monitor and report any incidents discovered such as theft, vandalism, trespassing, illegal dumping, and safety concerns. EXPERTISE WITH FEDERAL, STATE & LOCAL LAWS AND DISTRICT REQUIREMENTS

For three decades, Habitat West has had first-hand experience working on contracts that have been permitted by federal and state agencies, while gaining invaluable insight and experience with the permit requirements for endangered species and sensitive habitats within the Southern California region. All of Habitat West's mitigation projects fall under some or all of the permit requirements from U.S. Fish and Wildlife (USFW), California Department of Fish and Wildlife (CDFW) and/or the Army Corp of Engineers (ACOE). Therefore, we are intimately familiar with the requirements necessary for agency sign off of native restoration habitats.

Experience Working with OCWD

Habitat West, Inc. has a highly trained field staff to perform native habitat restoration and maintenance services. Our Superintendent/Project Manager, Jim Corbett, has been with the company for 31 years. Mr. Corbett has been in charge of working with OCWD for over 22 years on a variety of native habitat projects. We have 10 staff members dedicated to working on OCWD projects, and the ability to bring in up to 20 more personnel if required. Of our dedicated 10-man crew, our two foremen, Jorge Torres and Ramon Camacho have each been working on OCWD habitat restoration projects for 15 years.

Habitat West, Inc. has a long history of working in unison with OCWD staff on numerous projects for many years. We just completed a three-year contract with OCWD that covers the Prado Basin portion of this scope of work. Soon we will be starting the final year of a three-year contract for the Orange County portion of the RFP. During our previous contracts with OCWD, our fully trained and experienced crew members installed the native habitats covered in the maintenance portion of this scope of work. We have maintained these sites since installation with the highest quality of expertise for many years. During this time, we have developed a working relationship with OCWD staff based on trust and confidence. This confidence has been earned over the years, as Habitat West's team has demonstrated that we have the ability to perform the services required in a professional and thorough manner.

Our firm has all the necessary tools to perform the Scope of Services for this project, including those for the installation and maintenance of irrigation systems. Each foreman is equipped with a 4-wheel drive vehicle that is set up with the tools needed for daily tasks. We also carry smart phones with internet capabilities to send photos to the office of plants or animals that may need identifying while in the field. All biomass is hauled legally to a green waste facility via our dump truck, trailer or trucks.

Habitat West is capable of responding anytime there is an unplanned urgent event on a jobsite. Our close proximity to the various jobsites will be an asset if there is an unexpected event requiring our services. All crews have cell phones for immediate contact throughout the day, and we offer an after-hours emergency contact number.

Since OCWD often has current construction projects taking place adjacent to our habitat maintenance sites, OCWD staff members are familiar with Habitat West's personnel. Our labor crews know how to perform their duties in a way that does not hinder any other OCWD projects taking place in the area.

Project Manager and Labor Force Site-Specific Experience

To demonstrate our Project Manager's experience and qualifications, he has written the following overview of the project sites. Habitat West has worked on all of the project sites listed in the Scope of Services. The site-specific knowledge that we have gained during previous contracts enables us to efficiently attend to the maintenance needs of each site, as we already know what to expect at each project location.

ORANGE COUNTY FACILITIES

Burris Basin

Burris Basin Riparian Corridor:

Habitat West has been maintaining this 5.8 acre area since 2015. Although irrigation is currently discontinued here, it is prone to weed infestation depending on the water level and amount of exposed shoreline of the basin. Water level determines the actual square footage of the area that needs to be maintained. For example when water levels are low, this greatly increases the size of the service area. Habitat West will base our personnel numbers and frequency of visits depending on how much shoreline is exposed and in need of maintenance.

Burris Basin Sycamore Grove:

Habitat West has maintained the Burris Sycamore Grove since 2015. This site is now well established and irrigation has been discontinued. When our maintenance crews observe trespassers (fishermen), they always report to OCWD security. This site will continue to be closely monitored and crews will be dispatched if any weed proliferation or vandalism is observed.

Burris Basin Pump Station:

Habitat West's project manager designed and installed the irrigation system, as well as the surrounding habitat in October 2016. We have maintained this area with the highest industry standards since then. We regularly perform manual system checks. This system has run problem-free since installation. The irrigation is now turned off and Habitat West is closely monitoring plant health. Weed growth is fairly low and consists mostly of mustard, tree tobacco, and crownbeard.

Burris Basin Peninsula:

Habitat West crews completed the mulefat and willow cuttings at the 4-acre Burris Peninsula on February 9, 2022. The site consists of two areas that are planted with willows, cottonwoods and mulefat cuttings. Habitat West crews hand watered cuttings until plants became established. Currently, we are providing long-term maintenance while working with OCWD not to disturb the Barn Swallow Breeding Program being conducted within the site. The site is in excellent condition.

Five Coves Basin Mitigation

Five Coves Riparian Tree Grove:

This area has been turned over to the City of Anaheim. It was mentioned during the pre-bid site walk that OCWD may be asked to provide assistance if required. Habitat West will be ready to assist if the need arises. We installed two of the four separate planting efforts at Five Coves and have maintained all areas of this site since 2015. Five Coves has a problematic irrigation system, mostly due to extensive damage caused by adjacent construction contractors. We have a clear understanding of this irrigation system and regularly assist OCWD staff with repairs.

Five Coves Basin Freshwater Marsh Pond:

The freshwater marsh is one of the smaller sites within the mitigation program. It does not contain any supplemental irrigation and is well established. Monthly weeding of the surrounding berm and rip rap is necessary to keep off-site sourced weeds from establishing within the habitat.

Conrock Basin / Huckleberry Basin Riparian Complex

Conrock Basin Riparian Stream:

Due to the nature of this site, which is located within an active fishing concession area, site inspections are required more frequently and regular trash removal is required. Crews routinely remove unwanted vegetation from the fishing access ramps and park bench areas to provide safe access for fishermen. Access trails are routinely trimmed back to prevent them from closing up with native growth. Weeding on this site mostly consists of removing crownbeard from the riparian shoreline habitat.

Conrock Basin Non-Native Tree Removal and Replant:

Habitat West's experienced team began removing non-natives from this 2.27 acre area in October of 2019. In 2020, Habitat West planted this area with a plant pallet provided by OCWD, and designed and installed a drip irrigation system. We have maintained this area since then and it is thriving. The irrigation system was turned off after plantings became self-sustaining and is currently being removed. This site is one of many that serve as a testament of the excellent work Habitat has provided for OCWD and showcases native habitat so dense and lush that crews must cut in trails so that OCWD can monitor wildlife activities.

Huckleberry Basin:

Habitat West began clearing the perimeter of Huckleberry Basin in 2019 for future planting efforts. In late 2020 Habitat West planted the area, and then designed and installed an irrigation system around the eastern half of the basin. We have provided long-term maintenance since then. Although this site is doing very well, it requires extra attention due to the proliferation of weeds from off-site sources. We regularly

inspect the perimeter fencing for holes providing illegal access. Trespassing incidents are always reported to OCWD staff and security, thus providing an extra set of eyes for OCWD. Weeding is performed regularly.

Mills Pond Riparian Forest and Marsh:

Habitat West crew members designed and installed approximately 50% of the irrigation system servicing this site. We then completed planting and have maintained the portion we installed, as well as the first restoration effort conducted by a previous contractor. We have a clear understanding of the site. Along with weeding efforts and irrigation repair, Habitat West will assist OCWD by clearing pathways and access to nesting boxes that are located along the water's edge.

Santiago Basin Perimeter:

Over the past several years, Habitat West has installed all three phases of restoration to create the combined total of four acres of Coastal Sage Scrub. We have maintained these areas since installation. We have a clear understanding of all irrigation systems on this site, as we designed and installed them. Our crews work carefully to ensure that sensitive and endangered species such as California Gnatcatcher and Least Bell's Vireo are not disturbed during our maintenance activities. Habitat West crews are always on the lookout for signs of illegal trespassing and always report to OCWD security when trespassing is discovered.

Santiago Bowl / Saddle Mitigation

Habitat West helped OCWD with the layout of the Santiago Basin Bowl. We determined the proper placement of the water tank and access roads for the 1.58-acre Riparian and Coastal Sage Scrub mitigation site. Habitat West's project manager and irrigation technician, Jim Corbett, designed a sound irrigation system for this project, complete with the point-of-connection from the existing mitigation. We completed the installation of this project on March 15, 2024, and have monitored and maintained it since then. This site is currently exceeding all expectations and is on track for early agency sign-off. This site is another example of a successful collaboration between OCWD staff and Habitat West.

PRADO BASIN

Prado Planting Areas

Habitat West has assisted OCWD with planting within the Prado Basin for many years. Over the past two decades Habitat West has successfully installed and maintained 21 of these 2-acre sites described in the scope of work. We completed the installation of the most recent site, Prado 22 (Pheasant Field Planting) in November of 2024. Habitat West is currently maintaining all active maintenance in Prado 18, Prado 19, and Prado 20. These sites are so dense in native coverage that recently OCWD requested that we create walking trails so staff members can conduct bird surveys. Some sites have proven to be more challenging due to soil conditions, herbivore activity and extreme weather within the Prado Basin areas. Habitat West has always risen to the occasion and provided sound solutions to complex problems to ensure that every project we have been entrusted with has ended in success.

Prado Research Ponds

Habitat West has assisted OCWD with preparing the Prado Research Ponds for ongoing experiments for the last three years. Work has mostly consisted of non-native species removal, but we are ready to assist with any tasks requested by OCWD.

HABITAT WEST SAFETY MANUAL

Habitat West's complete 320-page Safety Manual may be found on the flash drive that accompanies this proposal, due to the length of the document. The statement below is an excerpt from our manual.

Safety and Health Policy Statement

It is the policy of Habitat West, Inc. to provide a work environment that is inherently safe. The safety and health of our employees is of primary importance as they are our most important resource. Safety takes a commitment from all personnel within our organization. Habitat West, Inc. has developed a comprehensive safety program that addresses specific safety concerns and provides guidance for the performance of our individual job tasks within the framework of appropriate Occupational Safety & Health Administration (OSHA) standards.

There also may be times when Habitat West, Inc. requires its employees to meet safety policies that are specific to our company. If we implement these additional policies, they must have more stringent safety requirements than what OSHA has developed. These policies can be found listed in the Safety Program Addendum at the end of this safety program when applicable.

All employees will receive interactive safety training using the information contained in this safety program. For this training, we may have safety meetings, on-the-job training, on-line courses, formal instruction, and/or any other relevant methods needed. Safety training needs will be identified by continual reassessment of work methods, equipment, and work stations; as well as employee and management input. Frequent and regular workplace inspections will be conducted by supervisory personnel and/or other competent persons. Employees in violation of the established safety procedures of Habitat West, Inc. will be subject to our disciplinary procedures.

Observation of unsafe acts will be addressed immediately. At every workplace, there will be a competent person, by virtue of training or experience, who will have the authority to stop work. Additionally, all employees have stop work authority for their immediate task if they are aware of a safety hazard that cannot be immediately corrected. If an employee stops work for an unresolved safety hazard, the supervisor will be contacted immediately.

Equipment operator/owner manuals will be readily available and the safety procedures contained therein will be followed. Equipment will be inspected prior to use and, if defective, tagged out of service. Manufacturer's warning labels on all equipment will not be removed, painted over or defaced. Emergency medical response will be available at the workplace either by an emergency rescue service within reasonable distance, by time, or an assigned emergency responder.

Safety requires not only that each person understand and perform individual tasks in a safe manner, but also that each individual is aware of his surroundings and is actively involved in the safety of others. Each Employee is encouraged to contact their supervisor immediately should a safety or health risk exist so that corrective action may be taken immediately.

QUALITY CONTROL PLAN

Habitat West quality control plan is a proven check and balance system that we have utilized on OCWD contracts for many years. The start of each project or task begins with a request from OCWD staff or a suggestion from our Superintendent Jim Corbett to Principal Environmental Specialist David McMichael on an area of concern pertaining to one of the restoration sites, administration facilities, or trail systems. Next Mr. Corbett visits the site to create an action plan and the methodology that will be used to complete the task. Then Mr. Corbett will brief our two foreman Jorge Torres and Ramon Camacho each with 15 years of experience working on OCWD sites, on the objective of the task, methodology to be used, tools that will be required to complete the job, any safety concerns, and the completion timeframe. As the project is being performed by our well-trained experience staff, all activities are being supervised by our foreman with additional regular site visits from Mr. Corbett to assure the highest quality service is being provided



to the client. Mr. Corbett provides daily updates including photos showing progress and any deviations from the original plan to OCWD staff to assure that all objectives are being achieved in a cost-effective manner. When the task is complete a site walk is conducted by Mr. Corbett and both foremen to assure all task were completed as specified. If any deficiencies are noted crews are directed to correct them before moving on to the next task. Finally, OCWD staff are provided with the projected completion date and time to provide an opportunity for a final site walk and inspection. In addition, all activities performed are documented in detailed monthly reports and daily logs provided by Mr. Corbett to OCWD Principal Environmental Specialist.

Statement of Insurance Compliance

Habitat West will meet the insurance requirements listed in Exhibit C, Services Agreement, and will provide OCWD with the associated forms and documentation upon request.

Acceptance of OCWD Standard Contract Requirements

Failure to abide by this limitation is a basis for OCWD to rescind the proposed award and award to a different vendor and could result in a vendor being excluded from future procurement opportunities.*

Subject: AGREEMENT TO PACWEST FOR DISTRICT SECURITY SERVICES

SUMMARY

On May 17, 2023, the District amended Agreement No. 1496 with PACWEST to extend security services at all District locations and facilities for an additional year. Over the past two years, PACWEST has consistently delivered reliable service and demonstrated responsiveness to all additional requests from District staff. Based on their performance and proven dependability, staff recommends extending the agreement for an additional three-year term.

RECOMMENDATION

Agendize for May 21 Board meeting: Authorize amendment to Agreement No. 1496 to PacWest Security Services for three years for the amount of \$499,825.82 for the period of June 15, 2025, through June 15, 2026, \$522,738.82 for the period of June 15, 2026, through June 15, 2027, and \$547,539.63 for the period of June 15, 2027 through June 15, 2028.

BACKGROUND/ANALYSIS

On May 17, 2023, the Board approved an amendment to Agreement No. 1496 to renew the contract with PACWEST Security for an additional year. Since then, PACWEST has continued to deliver outstanding performance at both the Anaheim and Fountain Valley locations. PACWEST provides coverage at Fountain Valley from 6 am to 6 pm, Monday through Friday and 6:00 am to 08:00 pm on Board nights, and 24-hour coverage at Field Headquarters. The company has been highly responsive to all alarms and consistently provides detailed, thorough incident reports. Their personnel have proven effective in addressing challenges related to homelessness along the river and at various well sites.

PACWEST has also demonstrated a strong commitment to staff safety by dependably accompanying personnel to monitoring wells and other locations identified as potential security concerns. Additionally, they have accommodated all last-minute requests for extra security services — including weekend tours, special events, and after-hours functions — promptly and efficiently.

Due to rising costs associated with fuel, minimum wage increases, and higher benefit expenses, there is an increase in the proposed contract rates for the upcoming years.

Staff recommends renewing the contract with PACWEST for a three-year term, with the following annual amounts:

- \$499,825.82 for the period of June 15, 2025, through June 15, 2026
- \$522,738.82 for the period of June 15, 2026, through June 15, 2027
- \$547,539.63 for the period of June 15, 2027, through June 15, 2028

- 1) Approve the purchase of Microsoft subscription licenses, products and services from SHI International Corp. under the County of Riverside Agreement ITARC-00929 in the amount of \$260,658 (\$86,886 per year) for a term of three years commencing August 1, 2025 and authorize the General Manager to execute corresponding agreements with SHI and Microsoft Corporation, subject to legal counsel review; and
- 2) Authorize the General Manager approve amendments of up to 10% of the contract value.

BACKGROUND/ANALYSIS

The District currently licenses MS software to meet its daily operating needs and business functions, primarily licensing O365 subscription licenses and other MS software for all District employees. O365 consists of MS Exchange Online (for email and calendar services), MS Word, MS Excel, MS PowerPoint, MS Access, MS Teams for communications and telephone services, MS OneDrive and MS SharePoint for file sharing services, as well as other utility

and security services.

Over the years, the District has licensed the O365 and other Microsoft subscription licenses through Liftoff, LLC, and has purchased other MS licensing through various vendors as the need occurred. The subscription licenses ensure the software is continually supported with updates, patches and related services to maximize functionality and information security. The current subscription licenses end on July 31, 2025 and are due for renewal.

O365 has proven to be reliable and robust and brings with it many advantages of the Microsoft cloud, including universal access and the ability to take advantage of Microsoft's considerable infrastructure. These licenses provide staff access to O365 applications in Microsoft's Office 365 US Government Community Cloud (GCC). Microsoft created the GCC plan to provide high-level security for public agencies. The GCC stores content in Microsoft's government data center servers that are physically located in the United States and segregated from commercial businesses O365 services.

Using O365 provides a number of benefits. It allows the District to benefit from Microsoft's platform products seamlessly on an ongoing basis and ensures that the District has access to the latest software version. O365 uses cloud-based services, thus reducing both hardware and software maintenance and replacement costs. O365 also provides eDiscovery and multi-mailbox search functions that helps staff perform Public Record Request email search queries. Security features in O365 includes resiliency and recoverability for email and file sharing data in the cloud, high-level encryption on all email content with built-in anti-spam and anti-malware, and continuous email access even in the event of disruption to the District's network.

On April 16, 2024, the County of Riverside issued a Request for Quotes (RFQ) for Microsoft Enterprise Licensed Support Providers. The County received seven quotes from qualified vendors, including SHI and Insight, of which SHI offered the best price. On September 10, 2024, the County of Riverside executed an agreement with SHI for a three-year period ending October 31, 2027, with an option to renew for an additional three-year period ending on October 31, 2030. The LSP agreement allows other public agencies, such as the District, to purchase MS Products and Services at a discounted price by taking advantage of volume pricing and locking in longer terms. The County's previous similar contract was used by over 900 government agencies who benefited from lower rates, as well as an agreement covering comprehensive products and services.

Staff solicited three (3) quotes for O365 subscription licenses, and additional MS software subscriptions used by District staff from three (3) authorized Microsoft Licensing Solution Providers (LSP):

SHI and Insight provided the lowest cost through their MS LSP agreements. Under the MS LSP agreement, pricing is fixed during the agreement period. Staff also requested a quote

from Liftoff as the District has previously purchased O365 subscription licensing from them. Although Liftoff does not have an MS LSP agreement with the County of Riverside, they did provide a discounted quote.

Because SHI has the lowest price quoted, staff recommends moving forward with SHI.

Staff recommends acquiring MS licensing, products and services by using the competitively bid Riverside LSP Agreement ITARC-00929 with SHI as they provided the lowest quote, and it is the most cost-effective option in the amount of \$260,658 for a three-year period commencing August 1, 2025, payable annually (\$86,886) and authorize the General Manager to execute corresponding agreements with SHI and Microsoft Corporation, subject to legal counsel review. Additionally, as the District may have additional MS software requirements that arise during the term of the agreement, staff recommends authorizing the General Manager to approve amendments to the agreement of up to 10% of the contract value.

This fiscal year's (2024/25) Information Services (IS) General Fund budget includes \$80,000 for O365 subscription licensing as well as funding of up to \$55,000 for additional software purchases and \$15,000 for online services. Next fiscal year's (2025-2026) IS General Fund budget includes \$82,000 for O365 subscription licensing as well as funding of up to \$50,000 for additional software purchases and another \$15,000 for online services and would be budgeted for the subsequent fiscal year (2026-2027) as appropriate and with budget approval by the Board of Directors. Where feasible and/or necessary, MS products would be purchased using the agreement during its term.

Staff recommends acquiring MS licensing, products and services by using the competitively bid Riverside LSP Agreement ITARC-00929 with SHI as they provided the lowest quote, and it is the most cost-effective option in the amount of \$260,658 for a three-year period commencing August 1, 2025, payable annually (\$86,886) and authorize the General Manager to execute corresponding agreements with SHI and Microsoft Corporation, subject to legal counsel review. Additionally, as the District may have additional MS software requirements that arise during the term of the agreement, such as potentially increasing the number or type of O365 licenses, increasing MS Teams telephony licensing, or upgrading file servers software, staff recommends authorizing the General Manager to approve amendments to the agreement of up to 10% of the contract value.

Subject: SANTA ANA WELL CONSTRUCTION LOAN AGREEMENT

SUMMARY

On November 15, 2024, the Board approved the Producers Well Construction Loan Program draft template Agreement. The City of Santa Ana (City, Santa Ana) has submitted an application and requested to be included in the loan program for \$10 million. Staff recommends approving the agreement with Santa Ana.

RECOMMENDATION

Agendize for May 21 Board meeting: Approve the New Well Construction Loan Agreement with Santa Ana up to \$10 million.

BACKGROUND/ANALYSIS

The Producers Well Construction Loan Program template Agreement was approved by the Board on November 15, 2024. It is a template agreement, with the understanding that each Producer requesting to be part of the loan program may be slightly different and each Producer submit an application, which is included in the Agreement.

The first approved well loan agreement was with the City of Seal Beach in February 2025. Santa Ana has submitted the second application for a new well construction loan. The production well is referred to as the Washington Well (# 42) and is part of Santa Ana's long-term infrastructure renewal and water system resiliency efforts. The new water well has already been drilled, constructed and is being developed at 651–657 E. Washington Avenue, Santa Ana. This well will address low-pressure deficiencies and support the upper zone of the City's water distribution system.

In 2020, Tetra Tech was retained to develop the PS&E (Plans, Specifications, and Estimates) package for the new well project. Phase I (Well Drilling) began in 2023 and was completed in Fall 2024. The City is now advancing to Phase II, which involves equipping and commissioning the new well and is the basis for the loan request. The scope of work includes the construction of a new well building, installation of mechanical, electrical, and system control systems for operational efficiency, and the

construction of approximately 1,700 linear feet of 16-inch water main pipeline to connect the new well to the City's upper zone.

Well 42 is expected to yield approximately 5,000 acre-feet per year, bolstering the City's supply and reliability and will enhance water system reliability and resiliency, provide critical support to areas with existing low-pressure issues and strengthening emergency preparedness through the upper zone.

The City loan request is for \$10.0 million over a 20-year term. This is the second loan application received, and staff recommends approving and executing the loan Agreement for the City's Well 42 Phase II work. Once the loan Agreement is executed, the interest rate will be locked and then staff will amortize the loan at substantial completion of the project. This loan will be partially funded from reserves and by annual Replenishment Assessment revenues.

Debt Service expenditures are \$1.8 million under budget. Replacement & Refurbishments are \$11 million under budget and Water Purchases are \$1 million under budget.

RECOMMENDATION

BACKGROUND/ANALYSIS

Attachment A provides an overall summary of the District's various operating costs for the third quarter fiscal year 2024-25 to date. Attachment B provides a budget to actual summary of the 21 cost centers that comprise the general fund and attachment C provides the details of these 21 cost centers. The District's revenue performance is summarized in attachment D.

General Fund

General Fund costs are \$4.1 million under budget due to lower than planned expenses in Forebay Operations, Water Production, Board Admin, offset with more than planned expenses in Hydrogeology. Specific details on the expense categories that make up this variance can be found in the footnotes to the reports in attachments B and C.

Debt Service

Debt service is under budget by \$1.8 million, primarily due to lower than planned variable interest rates on its 2003A certificate of participation debt.

Water Purchases

Water purchases are \$1 million less than budget due to elevated basin levels requiring less injection in the Alamitos Barrier to maintain protective levels to prevent seawater intrusion.

Replacement & Refurbishment

The Santiago Floating Pump Station project, the Orange Storm Drain at Bond Basin project and the Anaheim Valve Vault R&R projects are lower than the nine-month budget by \$6.5 million. These projects are anticipated to ramp up in the summer/fall months.

Revenues

Replenishment Assessment revenues were \$5.1 million more than planned in the nine months of the year. The year-to-date budget for groundwater pumping is approximately 219,000 acre-feet and actual pumping was approximately 226,445 acre-feet or 3% more than planned.

Investment Revenues are \$4.4 million more than planned due to investment interest rates year-to-date more than planned.

Rent and Other Revenues are \$6.3 million more than budget for the nine months largely due to the District receiving \$3.2 million litigation settlement and \$1.6 million of annual annexation fees.

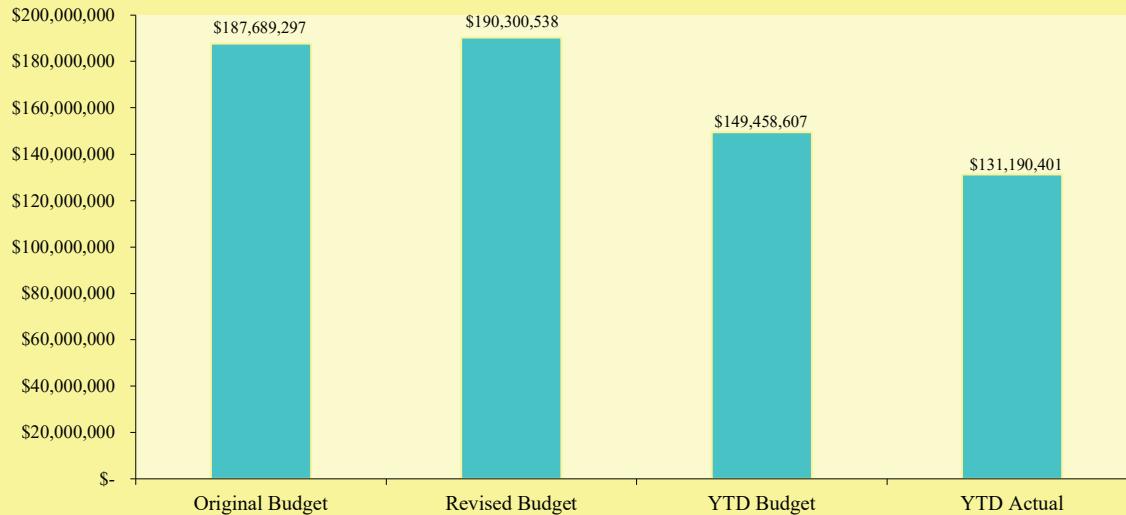

Operation Expenses

For the Third Quarter Ending March 31, 2025

General Fund expenses were \$4.1 million less than the revised YTD budget of FY2024-25:

- **Board Admin:** \$213K less than planned Board election expenses, which these expenses occur every other year.
- **Water Production:** \$2 million less than planned expenses for chemicals used in the Groundwater Replenishment System, such as sodium hypochlorite, anti-scalant and citric acid chemicals are lower than budget in the 9 months.
- **Forebay Operations:** \$240K lower than planned electrical costs, due to less movement of water from the Burris Basin to Santiago Basin for capture and recharge of stormwater.
- **Hydrogeology:** \$400K more than planned professional services for legal, due to an unanticipated settlement related to South Basin litigation.

Operation Expenses, continued

Replacement & Refurbishment - \$11 million lower than the YTD Budget.

- \$6.5 million of R&R projects anticipate phases to complete later this year:
 - Santiago Floating Pump Station \$2.3 million less than budget (Phase 1 construction is completing and Phase 2 will start late in 2025.)
 - Orange Storm Drain at Bond Basin \$2.3 million less than budget (construction anticipated to start this summer or fall.)
 - Anaheim Valve Vault \$1.8 million less than budget (construction anticipated to start this summer or fall.)
