6. Resolution Commending Director Bruce Whitaker for his Service to OCWD

RESOLUTION NO. 24-12-152  
COMMENDING BRUCE WHITAKER FOR HIS DEDICATED SERVICE AS AN  
ORANGE COUNTY WATER DISTRICT BOARD MEMBER

WHEREAS, Bruce Whitaker, a dedicated member of the Orange County Water District (OCWD) Board of Directors, was appointed by the Fullerton City Council to represent OCWD's Division 10 (Fullerton) from August 2012 to January 2014, February 2017 to February 2019, and January 2021 to December 2024; and

WHEREAS, Bruce Whitaker successfully led OCWD in accomplishing its core operation to manage, replenish and protect the Orange County Groundwater Basin – Orange County's largest source of drinking water – in a financially sound manner. The basin provides approximately 85% of the water supply to 2.5 million residents in north and central Orange County; and

WHEREAS, Bruce Whitaker championed water reuse by serving on the steering committee for the Groundwater Replenishment System, the world's largest system for indirect potable reuse, which under his guidance, accomplished its final completion with a capacity to produce 130 million gallons of water per day; and

WHEREAS, under Bruce Whitaker's leadership, OCWD garnered accolades for innovation, financial management, public outreach, and excellence in engineering; and

WHEREAS, Bruce Whitaker was a respected, acclaimed and honorable board member who worked well with his colleagues and staff to advance programs and projects that best served OCWD and his constituents; and

WHEREAS, in addition to his role at OCWD, Bruce Whitaker contributed to regional water management as a commissioner and chair of the Santa Ana Watershed Project Authority, a Joint Powers Authority (JPA) that plans and builds projects increasing water supply, protecting water quality and increasing sustainability within the Santa Ana River Watershed. He also served as a board member and chair of the Santa Ana River Flood Protection Agency, a JPA that works to address flood hazards from the Santa Ana River; and

WHEREAS, Bruce Whitaker served on the Fullerton City Council from November 2010 to December 2024, including two terms as mayor, where he prioritized transparency, fiscal responsibility and community engagement; and

WHEREAS, Bruce Whitaker's extensive public service also includes roles on the Orange County Vector Control District and County of Orange Oversight boards, planning commissioner for Fullerton, founder of the Fullerton Association of Concerned Taxpayers; and statewide coordinator of Municipal Officials for

Redevelopment Reform, among many others. He has held positions in legislative affairs and community development, reflecting a deep commitment to state and local government; and

NOW, THEREFORE, let it be resolved that the Board of Directors of the Orange County Water District does hereby officially commend and congratulate Bruce Whitaker on his dedication and successful leadership at the Orange County Water District. WHEREAS, the Water Issues Committee of this Board has recommended approval of the Engineer's Report for the City of Garden Grove Wells 22, 26, and 27 PFAS Treatment Systems Project and has determined the project feasible, necessary and beneficial to the lands of the District;

WHEREAS, the Water Issues Committee of this Board recommends awarding the contract the lowest responsive bid and responsible bidder, RBA Builders LLC, in the amount of \$959,927.

WHEREAS, the Water Issues Committee of this Board further recommends increasing the existing purchase order to IDS Group, Inc. in the amount of \$35,046 for construction support services and increasing the overall project budget by \$145,000.

NOW, THEREFORE, the Board of Directors of the Orange County Water District does hereby resolve as follows:

WHEREAS, the Political Reform Act requires local government to review its Conflict of Interest Code biennially to determine its accuracy; and

WHEREAS, the Administration and Finance Issues Committee of this Board has reviewed the OCWD Conflict of Interest Code and appendices thereto and has recommended adoption of an amended Appendix “A” to the OCWD Conflict of Interest Code to reflect appropriate staff assignments;

NOW, THEREFORE, the Board of Directors of the Orange County Water District does hereby resolve as follows:

Section 1: Additional funds in the amount of \$140,000 for R&R account R24024 for refurbishment or replacement of field recharge operations infrastructure and equipment are hereby authorized.

Section 2: Work Order No. 4 of Agreement No. 1450 and payment to Doty Bros. Construction Company as outlined herein is hereby ratified.

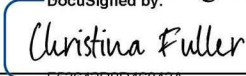
