8. Future of the Prado Wetlands

Natural Resources Director Sheryl Parsons reported that current operation and maintenance of the Prado Constructed Wetlands as nitrogen treatment wetlands requires a large maintenance commitment from OCWD's Operations staff. She advised that recent modeling has shown that the wetlands are no longer required to be operated as treatment wetlands which presents an opportunity to rethink how to operate and maintain the wetlands to reduce the maintenance burden on staff. She stated that staff proposes to discontinue use of North, South, and West ponds as treatment ponds. She reported that staff is proposing to hire a consultant to develop design plans for enhancements to interpretive infrastructure at Prado Wetlands and Field Office, and to improve visitor experience by enhancing seating and providing shading, restrooms, and water stations. Ms. Parsons noted that the design cost is estimated to be in the range of \$60,000 to

\$100,000 and the estimated construction cost to implement these improvements is approximately \$200,000 to 250,000. She noted that OCWD would seek grant funding for these new facilities.

#### RESOLUTION NO. 25-8-132

#### AUTHORIZING ISSUANCE OF A REQUEST FOR PROPOSALS (RFP) FOR A CONSULTANT TO DEVELOP A CONCEPTUAL DESIGN PLAN AND DISCONTINUING USE OF NORTH, SOUTH, AND WEST PONDS AS TREATMENT PONDS

WHEREAS, recent modeling has shown that the wetlands are no longer required to be operated as treatment wetlands to meet downstream nitrogen standards;

WHEREAS, staff recommends hiring a consultant to develop design plans for enhancements to interpretive infrastructure to support tour groups at Prado Wetlands and Field office and to improve visitor experience by enhancing seating and providing shading, restrooms, and water stations to improve comfort and safety;

WHEREAS, staff further recommends issuing a Request for Proposals (RFP) for a consultant to develop a conceptual design plan for enhancements that support and expand the site's touring capabilities.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Directors of Orange County Water District.

Section 1: Discontinued use of North, South, and West ponds as treatment ponds is hereby authorized.

Section 2: Issuance of an RFP for a consultant to develop a conceptual design plan for enhancements that support and expand the site's touring capabilities is hereby approved.
