LIMITATION AND SURCHARGE

SUMMARY

The District Act requires a public hearing be held each April to establish the Replenishment Assessment (RA), Additional Replenishment Assessment (ARA), Basin Production Percentage (BPP), Production Limitation and Surcharge, and the Basin Equity Assessments (BEA).

The attached resolutions are based on establishing the combined RA and ARA at \$688 per acre-foot. The BPP would remain at 85%. A Production Limitation of 100% would be established along with a Surcharge of \$2,000/acre-foot for groundwater production above the Production Limitation.

The rates established by the Board will become effective July 1, 2024.

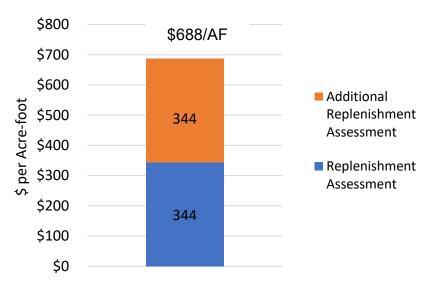

DISCUSSION

On March 20, 2024, a public hearing was held on the Water Year (WY) 2022-23 Engineer's Report, which provided information on groundwater conditions, water supply, and basin utilization. At that meeting the Board scheduled a public hearing for April 17, 2024, to consider the need and desirability to levy replenishment and basin equity assessments.

The proposed budget discussed with the Board on March 6, 2024, recommended increasing the combined RA and ARA from \$624 to \$688 per acre-foot. The BPP was proposed at 85%. After several meetings with the Board and Groundwater Producers, no change has been made to those recommendations.



WY 2024-25 Recommended RA and Additional RA

Optional RA Increase

Staff was previously requested to consider options to reduce the size of the RA increase. Such an option was discussed with the Administrative Finance Committee on April 11. The option is based upon reducing the amount of outstanding principal that is paid on the Commercial Paper program, which has a current outstanding balance of \$12.9 million. Interest payments on this debt is currently at 3.55%.

Staff recommends paying down this balance over the next two fiscal years with payments of \$8.5 and \$4.4 million. However, the option developed calls for the District to pay down this debt over five years with five equal payments of \$2.58 million. The RA

would then decrease to \$668/acre-foot in FY2024-25 providing some rate relief. Staff's original recommendation for the more aggressive repayment schedule and higher RA was primarily based upon:

- Fitch has commented that the District has too much debt (leverage) for the size of its operations which has the potential to negatively impact the AAA credit rating.
- With the PFAS situation, it is difficult to predict groundwater pumping and the associated RA revenues. The more aggressive repayment schedule gives the District more options if pumping and revenues are less than predicted.
- The Replenishment Assessment would be higher than planned in fiscal years 26-27 through 28-29 with the longer repayment schedule.
- Approximately \$0.8 million in additional interest costs would be incurred with the longer repayment schedule.
- Repaying debt as quickly as possible to avoid additional interest costs is generally a good practice.

The Administrative Finance Committee did not support this option.

Overdraft Projections

Staff previously estimated the June 30, 2024, accumulated overdraft would be in the area of 168,000 acre-feet, which is reflected in the March 20, 2024, Engineer's Report. The official overdraft for June 30, 2024, will be calculated in July and August and presented to the Board in September. For WY 2024-25, with the recommended 85% BPP, the accumulated overdraft would decrease by approximately 21,000 acre-feet assuming average hydrological conditions. The following table provides the figures supporting that estimate.

Basin Production Percentage (BPP)

The BPP is the ratio of groundwater to groundwater plus supplemental water used within OCWD. The FY 2024-25 budget and the attached resolutions are based on establishing a BPP of 85%. Total groundwater pumping for use within the District is expected to be in the area of 292,000 acre-feet. This pumping estimate accounts for the impacts of PFAS regulations causing some Groundwater Producers to discontinue pumping some wells.

The BPP can be changed during the fiscal year via a public hearing process.

Basin Equity Assessment (BEA)

The BEA is paid for groundwater pumping by a Producer that exceeds the BPP and is assessed in addition to the RA and ARA. The District Act gives OCWD the discretion to set the BEA at a "uniform or non-uniform" amount for the Producers. Historically, the District has set the BEA at an amount so that groundwater pumped above the BPP costs the same as imported water. Therefore, any Producer who decides to pump above the BPP is not getting a water supply pricing advantage over Producers who pump to the BPP.

The BEA for FY2024-25 has been reduced by \$200/acre-foot for most Groundwater Producers to encourage additional pumping. In general groundwater pumping continues to be less than expected due to PFAS. Any Producer groundwater pumping above the 85 percent BPP would pay an average BEA rate of \$432 per acre-foot.

Production Limitation and Surcharge

The District also has the authority to establish a Production Limitation and Surcharge to limit groundwater production. Any groundwater pumping above the Production Limitation would pay the Surcharge in addition to the RA, ARA, and BEA (if the groundwater pumping is above the BPP). The Production Limitation is an additional tool to assist the District in managing groundwater pumping, achieving overall basin management goals, and preventing adverse impacts to the Basin.

The Production Limitation is an important tool in OCWD's ability to manage groundwater production within the Basin. The Production Limitation is currently set at 100% and staff recommends maintaining it at 100% for WY2024-25 in order to protect the health of the Basin. The Surcharge for groundwater pumping above the Production Limitation is a penalty used to enforce the Production Limitation - It is not a water rate or other revenue producing assessment. Just as in WY 2023-24, the WY 2024-25 recommended surcharge of \$2,000 per acre foot is intended to penalize excessive production above a Producer's total water demand within the District. The surcharge is not intended to generate revenue, and no revenue from the surcharge is forecast in the OCWD Budget.

In order to have a sufficient deterrent, the Surcharge must impose a sufficiently large cost so as to strongly disincentive prohibited conduct by a Producer, conduct that

individually or cumulatively could harm the Basin or otherwise impose costs upon the operations of other Producers. If each Producer pumped at or above its total water demand within the District, the result would be an additional overdraft of approximately 55,000 acre-feet per year. Indeed, OCWD has observed that excessive pumping by individual Producers has the potential to cause localized depressions in key production areas of the basin, potentially degrading water quality and reducing groundwater levels in nearby wells and necessitating new capital projects such as the Mid-Basin Injection Project to proactively mitigate potential adverse effects of localized over-extraction. The Production Limitation and Surcharge proposed herein are intended to prevent such adverse effects while protecting the water supply of the District for all Producers and water users within the District.

The Production Limitation and Surcharge send a strong pricing signal to the Groundwater Producers to not pump excessive amounts of groundwater. The OCWD Act does not specify the amount that the Board may set as a Surcharge, only that it is within the "discretion of the Board" to set the amount. The \$2,000 an acre foot surcharge proposed for WY2024-25, just as in WY 2023-24, was established with reference to the surcharge of \$2,400 per AF approved by the OCWD Board in WY 2009-10. At the time, \$2,400 an acre foot exceeded the penalty rate that the Metropolitan Water District (MWD) assessed for excessive use of imported water. In WY 2010-11, the OCWD Board again set a Surcharge to enforce and penalize violations of a Production Limitation. The WY 2010-11 Surcharge was approved by the OCWD Board at \$2,800 per AF. Any Surcharge would be ineffective as a penalty if it did not exceed the cost of a Producer purchasing imported water, and \$2,000 per acre foot is substantially less than the surcharges set by OCWD in WY 2009-10 and WY 2010-11. The reasons for recommending a Production Limitation and Surcharge in WY 2024-25 are further summarized below.

OCWD has Groundwater Producers with service area boundaries that extend outside of the District's boundaries. This creates a possible scenario where these Producers could pump more groundwater than their actual total water demands (groundwater and supplemental imported water use) within OCWD. Under this scenario the Producer could be serving groundwater outside of OCWD's service area in a manner that violates the OCWD Act since these areas have not been annexed into OCWD, and OCWD requires annexation into the District as a precondition of receiving groundwater produced within the District. Unlimited pumping within OCWD by Producers who use water outside of OCWD would make it virtually impossible to manage the Basin for the benefit of District residents (whose property taxes partially paid for OCWD's current and future facilities) as year to year demand of each exporting Producer, and the resulting cumulative overdraft each year, would be difficult to predict. OCWD only has limited facilities capable of replenishing and conserving water for the benefit of users within the District. They are sized to serve the total water demand of persons within the District. The demand for OCWD groundwater by persons outside of the District, on the other hand, is essentially limitless. The Production limitation reasonably limits each Producer to taking no more than their total water demand within the District, thereby allowing OCWD's existing facilities to protect the Basin and prevent basin-wide or localized overdrafts that harm users within the District.

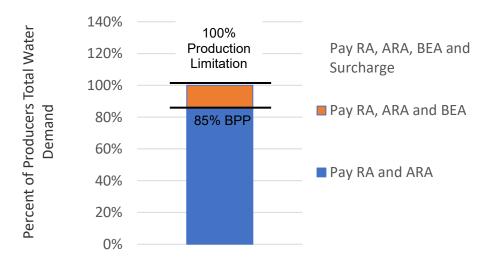
- Setting a 100% Production Limitation along with a Surcharge will disincentivize
 any Groundwater Producer from unilaterally pumping groundwater in excess of its
 total water demands within OCWD and potentially exporting the groundwater to
 agencies and persons outside of OCWD. The setting of a Production Limitation
 and a Surcharge could also deter this situation from occuring and thus avoid any
 necessary legal action against those Producers who seek to export water to lands
 that have not been annexed to the District.
- The Basin has an annual and an accumulated overdraft as defined by the District Act as documented in the annual Engineers Report on Groundwater Basin Conditions. The District works to reduce the overdraft and increase water storage supplies in the basin. It should be noted that total water demands (met by groundwater and imported water) within the District are typically around 370,000 acre-feet per year, however allowable groundwater pumping generally needs to be kept in the area of 315,000 acre-feet per year to match water supplies available to OCWD and being recharged in the Basin with existing or planned facilities to maintain a sustainable operation. If groundwater pumping were allowed to significantly increase for a few years, because Producers could pump in excess of their total water demand within District boundaries, the groundwater basin accumulated overdraft could grow reducing water supplies needed for drought periods. Additionally, seawater intrusion would be expected to increase in unprotected coastal areas, thereby potentially degrading the supplies of the District.

The recommended \$2,000/acre-foot Surcharge would make the cost of groundwater over the Production Limitation substantially greater than the cost of MWD Tier II treated non-interruptible water as shown below. This should be a sufficient amount to discourage and penalize groundwater production above the Production Limitation.

Future BPP and Production Limitation



OCWD has set a Production Limitation in most years since 1980, and in every year since WY 2009-10. Production Limitations are used by OCWD management to accomplish a variety of different basin management goals, including reducing groundwater pumping in specific areas of the District to prevent localized problems. For example, Groundwater Producers along the coast have been given a Production Limitation less than the BPP to reduce their groundwater pumping to assist in efforts to prevent seawater intrusion. In WY2001-02 and WY2002-03 the District gave Mesa Water District a Production Limitation of 65%. The BPP was 75% in those two years. The Mesa Production Limitation reduced Mesa's groundwater pumping along the coast and near an area of the basin where colored water was suspected of upwelling into the principal aquifer from deeper aquifers. The reduction in pumping assisted in efforts to prevent seawater intrusion and in efforts to prevent colored water from migrating into clear groundwater wells.

For these reasons, and in order to protect the water supply of the District, and to protect water users within the District, OCWD staff recommends that the Board adopt Resolutions A-D.

SUBJECT: MANAGER'S RECOMMENDATION ON REPLENISHMENT

ASSESSMENT RATES, BASIN PRODUCTION PERCENTAGE, AND

THE BASIN EQUITY ASSESSMENT RATES

Based upon the information included in the 2022-23 Engineer's Report on Groundwater Conditions, Water Supply and Basin Utilization in the Orange County Water District, dated March 2024, and other more recent data relating to groundwater and imported water supply conditions, it is recommended that the Board of Directors establish the following regarding the Replenishment Assessments (RA), Basin Production Percentage (BPP), Basin Equity Assessments (BEA) and Production Limitation and Surcharge for water year 2024-25.

- 1. That the Replenishment Assessment for the water year July 1, 2024 to June 30, 2025 shall be \$344 per acre-foot.
- 2. That the Additional Replenishment Assessment for the water year July 1, 2024 to June 30, 2025 for other than irrigation uses shall be \$344 per acre-foot.
- 3. That the fixed charge Replenishment Assessment for the water year July 1, 2024 to June 30, 2025 shall be \$688 for any water producing facility having a discharge opening not greater than two inches in diameter and which does not provide water for an area in excess of one acre.
- 4. That the Basin Production Percentage to achieve management objectives during the water year July 1, 2024 to June 30, 2025 is 85 percent.
- 5. That the Basin Equity Assessment be set at \$0/AF for such present Agricultural Irrigation Users who do not have a supplemental water connection.
- 6. That the Basin Equity Assessments to be levied against all other persons and operators on water produced from the groundwater in excess of the Basin Production Percentage is as shown in Table 1.
- 7. That a Production Limitation of 100% be established for all Groundwater Producers.
- 8. That a Surcharge of \$2,000/af be established for any water produced above the Production Limitation.

These recommendations are based upon current information included in the 2022-2023 *Engineer's Report* as follows:

RESOLUTION OF THE BOARD OF DIRECTORS OF THE ORANGE COUNTY WATER DISTRICT FINDING AND DETERMINING A GROUNDWATER BASIN OVERDRAFT EXISTS

WHEREAS, the report and recommendation of the General Manager on the amount of the replenishment rates, which includes a consideration of the amount of money necessary for replenishment purposes and to pay the costs of initiating, carrying on and completing any of the powers, projects and purposes of the District, has been heard; and

WHEREAS, pursuant to the provisions of the Orange County Water District Act, an engineering investigation and report concerning the condition of the groundwater supplies of the Orange County Water District has been filed and presented to the Board of said District, and a public hearing was held on March 20, 2024, for the purpose of considering the groundwater conditions of said District and to hear persons supporting or protesting the written engineering investigation and report on file with said District; and

WHEREAS, all notices as required regarding said hearing were given and all persons were permitted an opportunity to submit any evidence to this Board; and said matter was submitted to this Board of Directors for their finding and determination;

NOW, THEREFORE, BE IT HEREBY RESOLVED, that the Board of Directors of the Orange County Water District finds and determines that an overdraft, both annual (based on normal hydrology) and accumulated, does exist in the groundwater supplies of said District; and

BE IT FURTHER RESOLVED that this Board of Directors hereby finds and determines as follows:

1.	That the average annual overdraft for the immediate past five water years without supplemental replenishment water is
2.	That the annual basin overdraft for the current water year, July 1, 2023 to June 30, 2024 without supplemental replenishment water is estimated to be
3.	That the estimated annual basin overdraft for the ensuing water year, July 1, 2024 to June 30, 2025 without supplemental replenishment water is
4.	That the accumulated overdraft ¹ as of the last day of the preceding water year, June 30, 2023, is

Accumulated overdraft is defined in the District Act as "the amount of water necessary to be replaced in the intake area of the groundwater basin....to prevent the landward movement of ocean water into the fresh groundwater body, as determined by the board of directors from time to time."

5.	That the accumulated overdraft as of the last day of the current water year, assuming average hydrology June 30, 2024 is estimated to be	168,000 AF
6.	That the maximum amounts of water which could be purchased pursuant to the District Act from the Replenishment Fund for the replenishment of the groundwater supplies of the District for the ensuing water year is	123,000 AF
7.	That the recommended amount of water to be purchased for the replenishment of the groundwater supplies of the District for the ensuing water year, excluding supplies for the Talbert seawater intrusion barrier, is	3,000 AF
8.	That the amount of money necessary to purchase the recommended amount of water to replenish the groundwater supplies of the District for the water year July 1, 2023 to June 30, 2024 is	\$6.0 millior

RESOLUTION B

RESOLUTION OF THE BOARD OF DIRECTORS OF THE ORANGE COUNTY WATER DISTRICT LEVYING REPLENISHMENT ASSESSMENT FOR WATER PRODUCED DURING WATER YEAR 2024-25

WHEREAS, the engineering investigation and report concerning the condition of the groundwater supplies of the Orange County Water District has been made and filed; and

WHEREAS, the report and recommendation of the General Manager on the amount of the replenishment rate, which includes a consideration of the amount of money necessary for replenishment purposes and to pay the costs of initiating, carrying on and completing any of the powers, projects and purposes of the District, has been heard; and

WHEREAS, on March 20, 2024, the District provided public documents on a potential increase to the Replenishment Assessment to be levied and imposed on each groundwater producer, and the basis and reasons for the proposed Replenishment Assessment; and

WHEREAS, a duly-noticed public hearing was held on March 20, 2024, concerning the condition of the groundwater supplies of this District and a duly-noticed public hearing was held on April 17, 2024, for the purpose of determining the need and desirability of levying a Replenishment Assessment; and

WHEREAS, no written protests were filed against the adoption, levy and imposition of the proposed Replenishment Assessment; and

WHEREAS, this Board has found and determined that an annual and accumulated overdraft does exist:

NOW, THEREFORE, the Board of Directors of the Orange County Water District does hereby resolve as follows:

<u>Section 1</u>: That the Board of Directors does hereby find and determine that it is necessary and desirable to levy a Replenishment Assessment and to fix the rate thereof for the purchase of water to replenish the groundwater supplies of said District and to pay the costs of initiating, carrying on and completing any of the powers, projects and purposes of the District for the ensuing water year.

<u>Section 2</u>: That, based upon the staff report and presentation, the proposed fiscal year 2024-25 budget presented by the General Manager, and the testimony and evidence presented at the public hearing, the Board of Directors finds and declares as follows:

(a) In accordance with Sections 23 and 27 of the Orange County Water District Act, the purposes of the Replenishment Assessment are to generate revenues sufficient to acquire water to replenish the average annual overdraft for the immediate five years plus an additional amount of water sufficient to eliminate over a period of not less than 10 years nor more than 20 years the accumulated overdraft, and to provide the services and to pay the costs of initiating, carrying on, and completing the powers,

- projects and purposes for which the District was organized and which are authorized by the Board of Directors;
- (b) The revenues derived from the levy and imposition of the Replenishment Assessment do not exceed the reasonable costs to the District of acquiring water, providing the groundwater management and replenishment services and carrying out the powers, projects and purposes for which the District was organized and which are authorized by the Board of Directors;
- (c) The Replenishment Assessment is imposed for groundwater management and replenishment services to pay the costs of initiating, carrying on, and completing the powers, projects and purposes for which the District was organized and which are authorized by the Board of Directors, which are not provided to or which do not provide a benefit to persons who are not charged directly or indirectly the Replenishment Assessment;
- (d) The manner in which the Replenishment Assessment is allocated to and imposed on any operator of a groundwater producing facility bears a fair and reasonable relationship to the operator's burdens on, or benefits received from, the District's groundwater management and replenishment services and such other projects and purposes for which the District was organized and which are authorized by the Board of Directors; and
- (e) No Replenishment Assessment shall be levied or imposed upon any operator of any groundwater producing facility unless that operator produces groundwater.

<u>Section 3</u>: That pursuant to the provisions of Section 27 of the Orange County Water District Act, and based upon the finding that an overdraft, either annual or accumulated, exists, a Replenishment Assessment is hereby levied and assessed against all persons operating water producing facilities and producing water during the ensuing water year, from July 1, 2024, to and including June 30, 2025, from the groundwater supplies of said District at the uniform rate of \$344 per acre-foot of water produced by all persons during the ensuing water year. The Board of Directors finds and determines that the replenishment rate of \$344 per acre-foot of water produced by all persons during the ensuing water year does not exceed the amount necessary to purchase sufficient water to replenish the average annual overdraft for the immediate five years, plus an additional amount of water sufficient to eliminate over a period of not less than 10 years nor more than 20 years the accumulated overdraft, plus an amount to pay the costs of initiating, carrying on and completing the powers, projects and purposes for which the District was organized.

<u>Section 4:</u> That the Secretary of this District is hereby instructed and directed to give notice of the levy of this Replenishment Assessment as required by the Orange County Water District Act.

RESOLUTION C

RESOLUTION OF THE BOARD OF DIRECTORS OF THE ORANGE COUNTY WATER DISTRICT LEVYING ADDITIONAL REPLENISHMENT ASSESSMENT AND FIXED CHARGE REPLENISHMENT ASSESSMENT FOR WATER PRODUCED DURING WATER YEAR 2024-25, AND DETERMINING THE REPLENISHMENT ASSESSMENT AND ADDITIONAL REPLENISHMENT ASSESSMENT EXEMPT FROM CEQA

WHEREAS, the engineering investigation and report concerning the condition of the groundwater supplies of the Orange County Water District has been made and filed; and

WHEREAS, the report and recommendation of the General Manager on the amount of the additional replenishment rate, which includes a consideration of the amount of money necessary for replenishment purposes and to pay the costs of initiating, carrying on and completing any of the powers, projects and purposes of the District, has been heard; and

WHEREAS, on March 20, 2024, the District provided public documents on a potential increase to the Additional Replenishment Assessment to be levied and imposed on each groundwater producer, and the basis and reasons for the proposed Additional Replenishment Assessment; and

WHEREAS, the Additional Replenishment Assessment is paid by all persons operating water producing facilities for all purposes other than irrigation as defined in the District Act; and

WHEREAS, a duly-noticed public hearing was held on March 20, 2024, concerning the condition of the groundwater supplies of this District and a duly-noticed public hearing was held on April 17, 2024, for the purpose of determining the need and desirability of levying an Additional Replenishment Assessment, and fixing the rate thereof; and

WHEREAS, no written protests were filed against the adoption, levy and imposition of the proposed Additional Replenishment Assessment; and

WHEREAS, this Board has heretofore levied a Replenishment Assessment against all persons operating water producing facilities and producing water during the ensuing water year, from July 1, 2024 to and including June 30, 2025, from the groundwater supplies of said District at the uniform rate of \$344 per acre-foot of water produced by all persons during the ensuing water year;

NOW, THEREFORE, the Board of Directors of the Orange County Water District does hereby resolve as follows:

<u>Section 1</u>: That the Board of Directors does hereby find and determine that it is necessary and desirable to levy an Additional Replenishment Assessment and to fix the rate thereof to pay the costs of initiating, carrying on and completing any of the powers, projects and purposes of the District for the ensuing water year.

<u>Section 2</u>: That, based upon the staff report and presentation, the proposed fiscal year 2024-25 budget presented by the General Manager, and the testimony and evidence presented at the public hearing, the Board of Directors finds and declares as follows:

- (a) In accordance with Sections 23 and 27.1 of the Orange County Water District Act, the purpose of the Additional Replenishment Assessment is to generate revenues sufficient to provide the services and to pay the costs of initiating, carrying on, and completing the powers, projects and purposes for which the District was organized and which are authorized by the Board of Directors;
- (b) The revenue derived from the levy and imposition of the Additional Replenishment Assessment shall not exceed the reasonable cost to the District of providing the groundwater management and replenishment services and carrying out the powers, projects and purposes for which the District was organized and which are authorized by the Board of Directors;
- (c) The Additional Replenishment Assessment is imposed for groundwater management and replenishment services and to pay the costs of initiating, carrying on, and completing the powers, projects and purposes for which the District was organized and which are authorized by the Board of Directors, which are not provided to or which do not provide a benefit to persons who are not charged directly or indirectly the Additional Replenishment Assessment;
- (d) The manner in which the Additional Replenishment Assessment is allocated to and imposed on any operator of a groundwater producing facility bears a fair and reasonable relationship to that operator's burdens on, or benefits received from the District's groundwater management and replenishment services and such other projects and purposes for which the District was organized and which are authorized by the Board of Directors; and
- (e) No Additional Replenishment Assessment shall be levied or imposed upon any operator of any groundwater producing facility unless that operator produces groundwater for purposes other than irrigation.

Section 3: That pursuant to the provisions of Section 27.1 of the Orange County Water District Act, the Board of Directors hereby finds and determines that it is necessary and advisable to levy an Additional Replenishment Assessment against all persons operating water producing facilities for all purposes other than irrigation at a uniform rate per acre-foot for water produced during the ensuing year for the purpose of paying the costs of initiating, carrying on and completing the powers, projects and purposes for which the District is organized. The Board of Directors further finds that the Additional Replenishment Assessment rate of \$344 per acre-foot of water produced from the groundwater supplies of the District is necessary for the protection of the water supplies of the District and that the amount is reasonable. An Additional Replenishment Assessment is hereby levied and assessed against all persons operating water

producing facilities and producing water from the groundwater supplies of said District for all purposes other than irrigation during the ensuing water year from July 1, 2024 to and including June 30, 2025 at the uniform rate of \$344 per acre-foot of water for a total of \$688 per acre-foot of water produced by said persons during the ensuing water year for purposes other than irrigation.

<u>Section 4</u>: Pursuant to Section 29 of the Orange County Water District Act, the Board of Directors of the Orange County Water District does hereby provide that the operator of any water producing facility within the District which has a discharge opening not greater than two inches in diameter and which does not provide domestic or irrigation water for an area in excess of one acre, in lieu of filing a sworn statement as to the production of groundwater, may pay a fixed Replenishment Assessment and Additional Replenishment Assessment in the amount of \$688 for water produced in the ensuing water year, namely July 1, 2024, to June 30, 2025.

Section 5: Based upon the staff report and presentation, the proposed fiscal year 2024-25 budget presented by the General Manager, and the testimony and evidence presented at the public hearing, the Board of Directors finds and declares that the adoption, levy and imposition of the Replenishment Assessment and Additional Replenishment Assessment do not constitute a "project" within the meaning of the California Environmental Quality Act ("CEQA") and are exempt from CEQA under Public Resources Code Section 21080(b)(8) and State CEQA Guidelines §§ 15378(b) (4) and 15273, because the Replenishment Assessment and Additional Replenishment Assessment: (a) involve the creation of government funding mechanisms or other government fiscal activities which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment; and (b) are for the purposes of meeting operating expenses (including employee wage rates and fringe benefits), purchasing or leasing supplies, equipment or materials, meeting financial reserve needs and requirements, and obtaining funds for capital projects necessary to maintain the level of service within the District's existing boundaries.

<u>Section 6</u>: That the Board of Directors does hereby find and determine that a producer who operates a groundwater production facility for irrigation purposes as defined in the District Act is not subject to payment of the Additional Replenishment Assessment due to the benefits the District receives from agricultural activity. These benefits include:

- Open tilled agricultural fields contribute to natural incidental recharge of the groundwater basin;
- The District does not incur the costs to provide water quality groundwater testing for agricultural users, which is provided to the operators of water producing facilities for purposes other than agriculture;
- The District and the operators of water producing facilities for agricultural purposes have little to minimal interaction in annual operations. Conversely the District and the operators of facilities for non-agricultural purposes regularly interact and/or coordinate operations. Examples include the MWD Conjunctive Use Program, the Coastal Pumping Transfer Program, attending meetings, coordinating on MWD issues, legislative advocacy, public outreach and the In-lieu program; and

• Some agricultural irrigation water migrates back into aquifer reducing the net impact of groundwater production for agricultural purposes.

<u>Section 7:</u> That the Secretary of this District is hereby instructed and directed to give notice of the levy of the Replenishment Assessment and this Additional Replenishment Assessment as required by the Orange County Water District Act, and to file a Notice of Exemption in accordance with CEQA.

RESOLUTION D RESOLUTION OF THE BOARD OF DIRECTORS OF THE ORANGE COUNTY WATER DISTRICT

ESTABLISHING THE BASIN PRODUCTION PERCENTAGE, PRODUCTION LIMITATION, PRODUCTION LIMITATION SURCHARGE, AND DETERMINING THE NEED AND DESIRABILITY TO LEVY BASIN EQUITY ASSESSMENTS AND AMOUNT THEREOF, AND DETERMINING SUCH ACTIONS TO BE EXEMPT FROM CEQA

WHEREAS, pursuant to Section 31.5 of the Orange County Water District Act, an engineering report on water production and the condition of water supplies within the Orange County Water District has been filed and presented to the Board of Directors of said District, and a hearing relating to said production and condition of water supplies was held on Wednesday, March 20, 2024; and

WHEREAS, a duly noticed public hearing was held on April 17, 2024, and evidence was submitted for the purpose of determining the need and desirability of levying Basin Equity Assessments and the amount thereof, as well as the need for establishing production requirements, limitations, and surcharges to enforce said limitations, and the extent thereof, and said matters having been submitted to the Board of Directors for its findings and determinations;

WHEREAS, as documented with Resolution A – Finding and Determining a Groundwater Basin Overdraft Exists, an annual and accumulated overdraft exists with the groundwater basin and the District does not want excessive unexpected quantities of groundwater to be produced, or production of groundwater to occur in a manner that has the potential to harm users of groundwater within the District, which the setting of a Production Limitation and a Surcharge will discourage and penalize.

NOW, THEREFORE, the Board of Directors of the Orange County Water District does hereby resolve as follows:

<u>Section 1</u>: That the Board of Directors does hereby find and determine for the ensuing water year July 1, 2024, to June 30, 2025, as follows:

- a. The estimated total amount of water to be produced by all persons or operators within the District from the groundwater within the District is 292,000 acre-feet. Approximately 17,000 acre-feet of this amount has been determined to receive either a partial or full Basin Equity Assessment exemption pursuant to Section 38.1 of the OCWD Act.
- b. The estimated total amount to be produced by such persons and operators from groundwater and supplemental sources is 352,000 acre-feet.
- c. The Basin Production Percentage is 85 percent. There are no basin Production Requirements.
- d. The Production Limitation is 100 percent of a Producer's total water demand within the District for all 19 retail Groundwater Producers and is necessary for the protection of the water supply of the District. The Surcharge for production in excess of the Production Limitation is \$2,000 per acre-foot.

- e. The Basin Equity Assessment and Production Limitations from groundwater within the District established by this resolution are necessary to prevent excessive groundwater production and to protect the water supply of the District and users of groundwater within the District.
- f. The District will lower the BEA by \$200/acre-foot to encourage additional groundwater pumping to the 19 retail Groundwater Producers except for the city of Huntington Beach, the city of Tustin, Mesa Water District and the Irvine Ranch Water District as these four agencies are in existing programs to pump over the BPP.
- g. The Basin Equity Assessment shall be set at \$0 per acre-feet for agricultural irrigation use producers who do not have a supplemental water connection, and that such amount is reasonable.
- h. The Basin Equity Assessments to be levied against all other persons and operators in a dollar amount per acre-foot of water produced from the groundwater supply (in excess of the basin production percentage) for all purposes including irrigation are as follows:

- j. The amount of each such Basin Equity Assessment is reasonable.
- k. During the ensuing water year, upon the District giving published notice thereof, pursuant to Section 6061 of the Government Code, in a newspaper of general circulation printed and published within the District at least 10 days prior to such hearing, a subsequent public hearing may be held to modify the basin production percentage, any Basin Equity Assessments, any surcharge, or any production requirement or limitation established by the District.

<u>Section 2</u>: That pursuant to Section 31.5(h) of the Orange County Water District Act, all persons and operators who produce 25 acre-feet or less of water from groundwater within the District shall be excluded from the levy of the Basin Equity Assessments and production requirements and limitations provided for herein.

<u>Section 3</u>: The Board of Directors finds and determines that the establishment of the basin production percentage, production limitations, and the adoption, levy and imposition of basin equity assessments and surcharges are exempt from the California Environmental Quality Act ("CEQA") under State CEQA Guideline §15378(b)(2) since they involve continuing administrative activities such as general policy and procedure making.

Section 4: Based upon the staff report and presentation, the proposed fiscal year 2024-25 budget presented by the General Manager, and the testimony and evidence presented at the public hearing, the Board of Directors finds and declares that the adoption, levy and imposition of the basin equity assessments, production limitations and surcharges do not constitute a "project" within the meaning of CEQA and are exempt from CEQA under Public Resources Code Section 21080(b)(8) and State CEQA Guidelines §§ 15378(b)(4) and 15273, because the basin equity assessments production limitations and surcharges: (a) involve the creation of government funding mechanisms or other government fiscal activities which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment; and (b) are for the purposes of meeting operating expenses (including employee wage rates and fringe benefits), purchasing or leasing supplies, equipment or materials, meeting financial reserve needs and requirements, and obtaining funds for capital projects necessary to maintain the level of service within the District's existing boundaries.

<u>Section 5</u>: That the Secretary of this District is hereby instructed and directed to give notice of the Basin Production Percentage, Basin Equity Assessments, the Production Limitation and the Production Limitation Surcharge as required by the Orange County Water District Act, and to file a Notice of Exemption in accordance with CEQA.

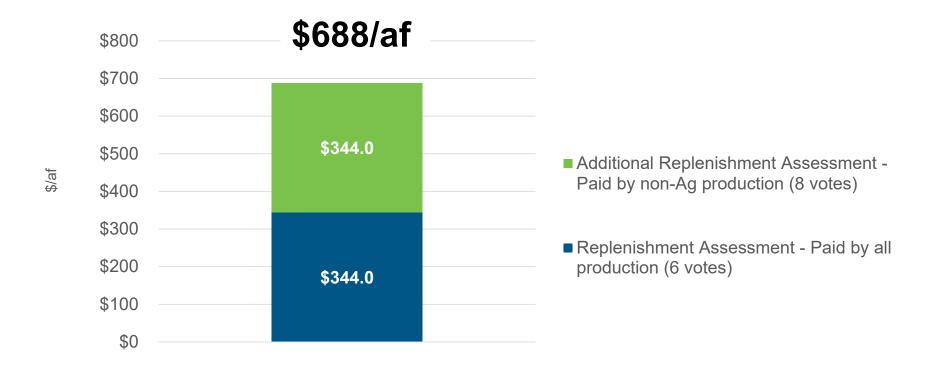

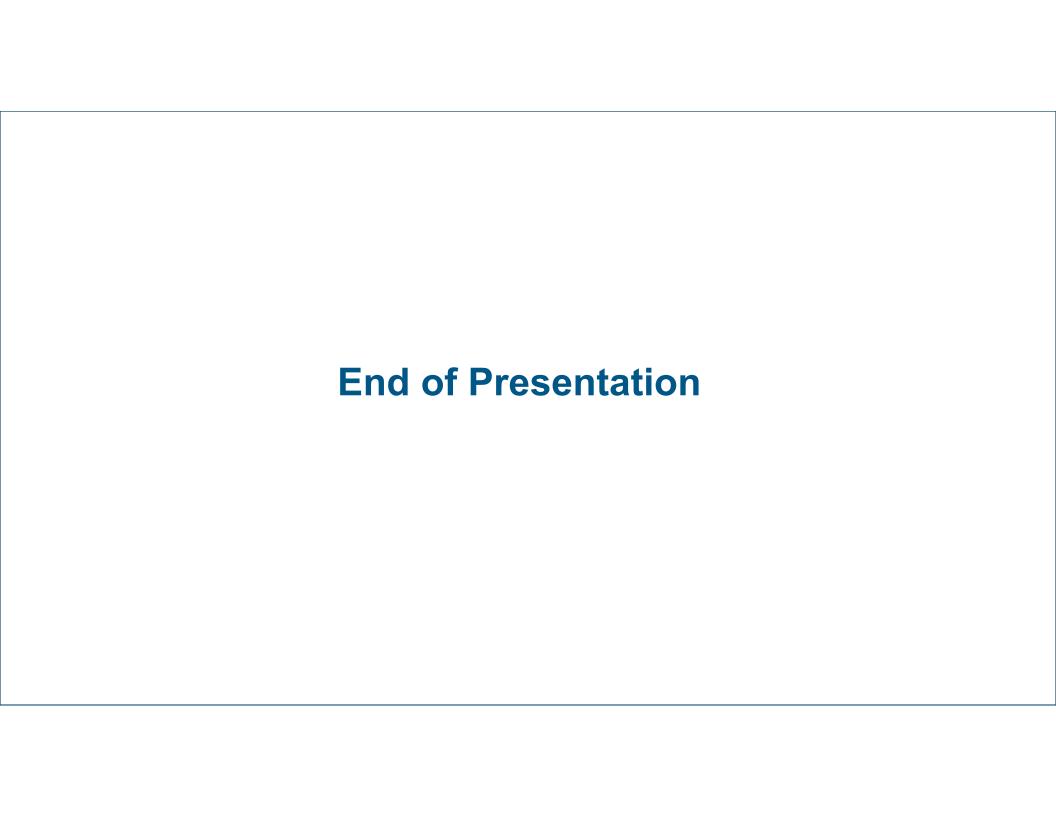

President Green called to order the March 20, 2024 regular meeting of the Orange County Water District Board of Directors at 5:30 p.m. Following the Pledge of Allegiance to the Flag, the District Secretary called the roll and reported a quorum as follows. VISITOR PARTICIPATION

There were no visitors wishing to address the Board at this meeting.

1. Public Hearing on 2022-23 Engineer's Report on Groundwater Conditions, Water Supply and Basin Utilization

President Green opened the Public Hearing to review the 2022-23 Engineer's Report on Groundwater Conditions, Water Supply and Basin Utilization. Executive Director of Engineering and Water Resources Chris Olsen reviewed the key findings of the Engineer's Report as contained in the staff report for tonight's meeting as follows:

- 1) Groundwater production totaled 245,210 acre-feet (af);
- 2) Groundwater stored in OCWD's basin increased by 69,000 af;
- 3) The accumulated overdraft on June 30, 2023 was 189,000 af;
- 4) The annual overdraft was 52,250 af;
- 5) Average annual overdraft for the immediate past five water years was 103,700 af;
- 6) Projected annual overdraft for the current 2023-24 water year is 98,000 af;
- 7) Projected annual overdraft for the ensuing 2024-25 water year is 110,000 af;
- 8) Projected accumulated overdraft on June 30, 2024 is 168,000 af;
- 9) Under the provisions of Section 27 of the District Act, a portion of the RA for the ensuing 2024-25 water year could be equal to an amount necessary to purchase up to 123,000 AF of replenishment water.

Mr. Olsen then reviewed the Water Supply and Basin Utilization summary of findings as follows: 1) water usage from all supplemental sources and non-local water sources totaled 107,723 af; 2) water usage from recycled water produced from within OCWD including the Groundwater Replenishment System (GWRS)

totaled 120,018 af; 3) water demands within OCWD totaled 351,719 af; and 4) estimated demands for groundwater for the ensuing 2024-25 water year are 292,000 AF.

President Green then opened the hearing for public comment. There being no persons wishing to present testimony, President Green declared the hearing closed and the Board took the following action.

Director Sheldon arrived during the discussion of the following item.

2. Public Hearing to Consider Petitions for Exemption of Payment of Replenishment Assessment and Basin Equity Assessment from Cities of Anaheim, Orange, Santa Ana, East Orange County Water District, Serrano Water District, and Yorba Linda Water District

President Green opened the Public Hearing to consider petitions for exemption from the Replenishment Assessment (RA) and the Basin Equity Assessment (BEA) from the cities of Anaheim, Orange, and Santa Ana, East Orange County Water District, Serrano Water District, and Yorba Linda Water District. General Manager John Kennedy advised that Anaheim, Orange, Santa Ana, East Orange County WD, Serrano WD, and Yorba Linda WD have requested RA/BEA exemptions or credits for well water discharged to facilities OCWD uses for recharge. He reported that Anaheim and Yorba Linda Water District (YLWD) also requested exemptions or credit for PFAS treatment system "flushing" water discharged to recharge facilities and noted that YLWD rescinded its request. Chief Hydrogeologist Roy Herndon stated that staff evaluated the eligibility for exemptions per the OCWD Act. He advised that 30 existing and five future wells are recommended for exemption. He stated that water pumped from wells at startup is typically high in turbidity and potentially exceeds bacteriological standards making it unsuitable for discharge to the potable system. Mr. Herndon reported that water from the agencies' wells specified in their petitions is conveyed to recharge facilities where it percolates to the Shallow aquifer with no net reduction to the groundwater basin supply. He stated that information is adequate to support consideration for an exemption from the RA/BEA for the petitioners' well water pumped to waste. He provided staff's evaluation of discharges from PFAS treatment facilities advising that treatment facilities do not meet the definition of a "water-producing facility" in the OCWD Act. He reported that treatment facilities are downstream of the wells and groundwater flow meters where the OCWD Act provisions apply. Mr. Herndon stated that since water discharged from treatment facilities is not subject to payment of the RA/BEA, there is no provision in the OCWD Act to exempt such water from the RA/BEA. He stated that the following alternative approach is available: 1) PFAS treatment system flushing is a normal activity during construction and startup to achieve stable and acceptable water quality – cost of this water can be included in the producers' reimbursable capital costs, and 2) Treatment system discharges to waste may be required during normal operation and maintenance and may be included in producers' annual O&M costs.

There being no persons wishing to present testimony, President Green declared the hearing closed and the Board took the following action.

DETERMINING "PUMP TO WASTE" WATER PRODUCED FROM SPECIFIED WELLS OWNED BY THE CITIES OF ANAHEIM, ORANGE, AND SANTA ANA, EAST ORANGE COUNTY WATER DISTRICT, SERRANO WATER DISTRICT, AND YORBA LINDA WATER DISTRICT IS UNSUITABLE FOR DOMESTIC USE DUE TO TURBIDITY AND/OR BACTERIA AND DOES NOT ADVERSELY AFFECT BASIN SUPPLIES;

DETERMINING FACILITIES DOWNSTREAM OF PRODUCTION WELLS ARE NOT SUBJECT TO THE PROVISIONS OF THE OCWD ACT; AND, EXEMPTING THE "PUMP TO WASTE" WATER PRODUCED FROM THE SPECIFIED WELLS OWNED BY THE CITIES OF ANAHEIM, ORANGE, AND SANTA ANA, EAST ORANGE COUNTY WATER DISTRICT, SERRANO WATER DISTRICT, AND YORBA LINDA WATER DISTRICT FROM PAYMENT OF THE REPLENISHMENT ASSESSMENT AND BASIN EQUITY ASSESSMENT

WHEREAS, the cities of Anaheim, Orange, and Santa Ana, East Orange County Water District, Serrano Water District, and Yorba Linda Water District submitted petitions formally requesting OCWD to exempt and/or provide credit for water "pumped to waste" from payment of the Replenishment Assessment (RA) and Basin Equity Assessment (BEA).

WHEREAS, staff has determined that water from the agencies' wells specified in their petitions is conveyed to recharge facilities where it percolates to the Shallow aquifer with no net reduction to the groundwater basin supply.

WHEREAS, staff has determined that information is adequate to support consideration for an exemption from the RA/BEA for the petitioners' well water pumped to waste.

WHEREAS, staff has determined that evaluation of discharges from PFAS treatment facilities do not meet the definition of a "water-producing facility" in the OCWD Act.

WHEREAS, since water discharged from treatment facilities is not subject to payment of the RA/BEA, there is no provision in the OCWD Act to exempt such water from the RA/BEA.

WHEREAS, staff has recommended the following alternative approach: 1) PFAS treatment system flushing is a normal activity during construction and startup to achieve stable and acceptable water quality – cost of this water can be included in the producers' reimbursable capital costs, and 2) Treatment system discharges to waste may be required during normal operation and maintenance and may be included in producers' annual O&M costs.

WHEREAS, the Board of Directors, upon the filing of such report, fixed March 20, 2024 as the time of said hearing and thereupon caused notice of the public hearing to be published as provided in Section 38.1 of said Act; and

WHEREAS, the notice as required by law has been given and a public hearing for the purpose of determining the need for exemption of water produced from said Water Producing Facility from levy of the Replenishment Assessment and Basin Equity Assessment has been held this 20th day of

March 2024, and all persons have been permitted an opportunity to be heard respecting this matter;

NOW, THEREFORE, the Board of Directors of the Orange County Water District does hereby resolve as follows:

DISCUSSION/ANALYSIS

AB 2079 Bennett (D-Oxnard) Groundwater extraction: large-diameter, high-capacity wells: permits. Bennett (D-Ventura)

This proposed legislation appears to be targeted toward protecting private wells from impact by large-capacity agricultural wells, particularly in areas with subsidence – not issues that have been a problem within OCWD's area, yet the current language could pose a problem for OCWD in the future. The bill also side steps the Sustainable Groundwater Management Act (SGMA), which is legislation that OCWD was a model for sustainably managing a groundwater basin. Therefore, OCWD staff and consultants recommend an "oppose" position. ACWA has an "oppose unless amended" position.

Below are some of the issues with AB 2079:

Given that public water supply wells and small system wells are exempted, this would likely not have a significant impact on OCWD – at least in the short term. That's because these represent probably >95% of the new wells with casing diameters >8 inches constructed in our basin. Looking longer term, the subsidence threshold of <0.5 foot since 2015 could become an impediment because over time that threshold could eventually be reached. The greatest cumulative subsidence from 2015 to 2023 in OCWD is a small area in Tustin with 0.2 foot. The legislation provides an exception to this if annual subsidence is <0.1 foot over a consecutive four-year period, which may be difficult to meet because OCWD's basin is prone to "elastic" (reversible) subsidence during several-year drought periods. The proposed legislation does not exempt "elastic" subsidence or non-groundwater-related (petroleum or tectonic) land surface decline. Removal of the subsidence language is needed. These issues are technical and vary site by site.

It is also foreseeable that the ability to implement groundwater remediation/protection projects like North Basin or MCAS El Toro could be impacted. That's because it may be necessary to construct extraction wells closer than ¼ mile from each other (particularly targeting different aquifer zones) to effectively capture/contain groundwater contamination. Remediation involving groundwater extraction could be further restricted in

areas with subsidence above the specified thresholds. <u>Groundwater remediation projects should be exempted if approved by the GSA.</u>

For the above reasons, and impacts to SIGMA legislation being circumvented, OCWD staff recommend an "oppose" position.

SB 1147 Portantino (D-Glendale): Drinking water: bottled water: microplastics levels

The bill would require the Office of Environmental Health Hazard and Assessment (OEHHA) to study the health impacts of microplastics in drinking water, including bottled water, to evaluate and identify safe and unsafe levels of microplastics in those types of water. OEHHA, on or before January 1, 2026, would be required to develop and deliver, to the State Water Board, the following:

- 1) Public health standards and goals for a safe level of microplastics in drinking water, including bottled water; and
- 2) Definitions for the terms "safe level of microplastics" and "unsafe level of microplastics."

The State Water Board, on or before January 1, 2028, would be required to adopt and implement the public health standards and goals for a safe level of microplastics in drinking water, including bottled water, developed, and delivered by OEHHA. The State Water Board would also be required to provide to local water agencies the public health standards and goals and the definitions for "safe level of microplastics" and "unsafe level of microplastics."

OCWD staff recommend a position of "Oppose Unless Amended" on SB 1147. The specific amendment would be that, upon the availability of adequate peer-reviewed, scientific health risk studies and high-quality monitoring results regarding consumer exposure, and upon request from the State Water Board, OEHHA will develop public health standards and goals for a safe level of microplastics in drinking water. Additionally, all dates and set requirements should be removed from the bill as there is currently minimal to no peer-reviewed, scientific health risk studies and exposure studies available to support the decision-making required by the bill.

Legislation to remove PFAS from consumer products:

OCWD and local ratepayers are currently dealing with an estimated \$1.8 billion impact over the next 30 years to remove PFAS chemicals from the groundwater basin that originated from manufacturers that added these chemicals to their consumer products. OCWD's legal counsel recommended that the District support legislation to reduce the input of PFAS into the Orange County Groundwater Basin. Therefore, OCWD staff and consultants recommend a "support" position on the four bills below to remove PFAS from consumer products, which inevitably may end up in water systems.

 SB 903 (Skinner D-Oakland) Environmental health: product safety: perfluoroalkyl and polyfluoroalkyl substances. SB 903 prohibits the sale of products containing intentionally added PFAS beginning January 1, 2030 unless DTSC determines that the use of PFAS in the product is a currently unavoidable use, the prohibition is preempted by federal law, or the product is used. The bill authorizes DTSC to adopt regulations to implement the bill and imposes civil penalties not to exceed \$1,000 for each day during which the violation continues and \$2,500 per day for ensuing violations. SB 903 is sponsored by the California Association of Sanitation Agencies (CASA).

- AB 2761 Hart (D, Santa Barbara) Product safety: plastic packaging: Reducing
 Toxics in Packaging Act. This bill would prohibit, beginning January 1, 2026, a
 person from manufacturing, selling, offering for sale, or distributing in the state
 plastic packaging that contains certain chemicals, including PFAS. The bill would
 exclude from that prohibition packaging used for certain medical, drug, and federally
 regulated products.
- AB 2515 Papan (D-San Mateo) Menstrual products: perfluoroalkyl and polyfluoroalkyl substances (PFAS). AB 2515 bans the sale of menstrual products containing intentionally added PFAS or, commencing January 1, 2027, which have the presence of PFAS at or above 10 parts per million. The bill makes the Department of Toxic Substances Control (DTSC) responsible for implementing and enforcing the ban and gives them authority to issue regulations to do so. The bill also creates a private right of action for enforcement of the ban and establishes civil penalties of \$5,000 for an initial violation and \$10,000 for subsequent violations.
- SB 1266 Limón (D, Oxnard) Product safety: perfluoroalkyl and polyfluoroalkyl substances. Existing law prohibits certain baby cups and bottles from containing bisphenol A. SB 1266 expands that law to cover any bisphenol or PFAS. The ban would become effective on January 1, 2025.

Background for PFAS-related bills:

Existing law prohibits any person from distributing, selling, or offering for sale in the state any food packaging that contains regulated perfluoroalkyl and polyfluoroalkyl substances (PFAS), as defined, and requires a manufacturer to use the least toxic alternative when replacing regulated PFAS in food packaging to comply with this requirement. Existing law similarly prohibits, beginning July 1, 2025, a person from manufacturing, distributing, selling, or offering for sale in the state any new, not previously owned, textile articles that contain regulated PFAS.

An act to amend Sections 108940 and 108941 of, to amend the heading of Chapter 12 (commencing with Section 108940) of Part 3 of Division 104 of, and to add Section 108942 to, the Health and Safety Code, relating to product safety.

LEGISLATIVE COUNSEL'S DIGEST

SB 1266, as amended, Limón. Product safety: perfluoroalkyl and polyfluoroalkyl substances. bisphenol.

Existing law, part of the hazardous waste control law, requires the Department of Toxic Substances Control to adopt regulations to establish a process by which chemicals or chemical ingredients in products may be identified and prioritized for consideration as being chemicals of concern and to adopt regulations to establish a process by which chemicals of concern may be evaluated. Existing law prohibits the manufacture, sale, or distribution in commerce of any bottle or cup that contains bisphenol A, as specified, if the bottle or cup is designed or intended to be filled with any liquid, food, or beverage intended primarily for consumption by children 3 years of age or younger. The prohibition above does not apply to a product subject to a regulatory response by the department as of the date that the department posts a prescribed notice regarding the department's adoption of the regulatory response. Existing law additionally requires manufacturers to use the least toxic alternative when replacing bisphenol A in containers, as specified. containers and prohibits manufacturers from replacing bisphenol A with chemicals known to cause cancer or reproductive harm, as specified.

This bill—would, on and after January 1, 2026, apply the above prohibitions and requirements to—all forms any children's feeding product or children's sucking or teething product, as defined, that contains any form of bisphenol and to perfluoroalkyl and polyfluoroalkyl substances, as defined, unless they are temporarily essential chemicals, as defined, bisphenol, as defined, at a detectable level above 0.1 parts per billion. The bill would authorize the department to establish standards for the children's products above that are more protective of

public health, sensitive populations, or the environment than the standards established by the bill. The bill would additionally prohibit manufacturers from replacing any form of bisphenol with any chemical identified by the department as a Candidate Chemical, as specified.

THE PEOPLE OF THE STATE OF CALIFORNIA DO ENACT AS FOLLOWS:

SECTION 1. The heading of Chapter 12 (commencing with Section 108940) of Part 3 of Division 104 of the Health and Safety Code is amended to read:

CHAPTER 12. Bisphenol-A

SECTION 1.SEC. 2. Section 108940 of the Health and Safety Code is amended to read:

- **108940.** (a) On and after January 1, 2025, 2026, no person shall manufacture, sell, or distribute in commerce any children's feeding product or children's sucking or teething product that contains any form of bisphenol or perfluoroalkyl or polyfluoroalkyl substances is a temporarily essential chemical. at a detectable level above 0.1 parts per billion.
- (b) Subdivision (a) shall not apply to medical devices, as defined in Section 109920, or to food and beverage containers designed or intended primarily to contain liquid, food, or beverages for consumption by the general population.
- (c) The Department of Toxic Substances Control may establish standards for any children's feeding product or children's sucking or teething product that are more protective of public health, sensitive populations, or the environment than the standards established pursuant to subdivision (a).
- (d) Notwithstanding subdivision (a), if the Department of Toxic Substances Control adopts a regulatory response described in Section 25253 regarding the use of any form of bisphenol or perfluoroalkyl or polyfluoroalkyl substances in a product that is prohibited by this section, the prohibition of this section shall not apply to that product upon the date that the department posts a notice on its internet website that it has adopted the response.
- (e) Notwithstanding subdivisions (b) and (c) of Section 25257.1, this section shall not be construed to prohibit or restrict the authority of the Department of Toxic Substances Control to prioritize or take action on any products containing any form of bisphenol or perfluoroalkyl or polyfluoroalkyl substances in order to limit exposure to or reduce the level of hazard posed by any form of bisphenol or perfluoroalkyl or polyfluoroalkyl substances. bisphenol.

SEC. 2.SEC. 3. Section 108941 of the Health and Safety Code is amended to read:

- **108941.** (a) Manufacturers shall use the least toxic alternative when replacing any form of bisphenol—or perfluoroalkyl or polyfluoroalkyl substances in containers in accordance with this chapter.
- (b) Manufacturers shall not replace any form of bisphenol—or perfluoroalkyl or polyfluoroalkyl substances pursuant to this chapter with chemicals classified by the United States Environmental Protection Agency as carcinogenic to humans, likely to be carcinogenic to humans, or for which there is suggestive evidence of carcinogenic potential, or identified by the state to cause cancer as listed in the Safe Drinking Water and Toxic Enforcement Act of 1986 (Chapter 6.6 (commencing with Section 25249.5) of Division 20) list of chemicals known to cause cancer or reproductive toxicity.
- (c) Manufacturers shall not replace any form of bisphenol or perfluoroalkyl or polyfluoroalkyl substances pursuant to this chapter with reproductive toxicants that cause birth defects, reproductive harm, or developmental harm as identified by the United States Environmental Protection Agency or listed in the Safe Drinking Water and Toxic Enforcement Act of 1986 (Chapter 6.6 (commencing with Section 25249.5) of Division 20) list of chemicals known to cause cancer or reproductive toxicity.
- (d) Manufacturers shall not replace any form of bisphenol pursuant to this chapter with any chemical identified by the Department of Toxic Substances Control as a Candidate Chemical pursuant to Section 69502.2 of Title 22 of the California Code of Regulations.

SEC. 3.SEC. 4. Section 108942 is added to the Health and Safety Code, to read:

108942. For purposes of this chapter, the following terms have the following meanings:

(a) "Bisphenol" means a chemical with two phenol rings connected by a single linker atom. The linker atom and phenol rings may have additional substituents.

(a)

(b) "Child" or "children" means an individual or individuals younger than 12 years of age.

(b)

(c) "Children's feeding product" means any consumer product, marketed for use by, marketed to, sold, offered for sale, or distributed to children in the State of California that is designed or intended by the manufacturer to be filled with any liquid, food, or beverage intended primarily for consumption from that bottle or cup by children.

(c)

- (d) "Children's sucking or teething product" means any consumer product, marketed for use by, marketed to, sold, offered for sale, or distributed to children in the State of California that is designed or intended by the manufacturer to help a child with sucking or teething in order to facilitate sleep or relaxation.
- (d)"Perfluoroalkyl or polyfluoroalkyl substances" means substances that are members of a class of fluorinated organic chemicals that contain at least one fully fluorinated carbon atom.
- (e)"Temporarily essential chemical" means a chemical for which all of the following are true:
- (1)There are no safer alternatives to the chemical available.
- (2)The chemical is necessary for the product to work as intended.
- (3)The chemical is being used in a product that is critical for the health, safety, or function of society.

SUMMARY

The District operates the Forebay recharge operations to maximize surface recharge of Santa Ana River stormwater, baseflow, GWRS, and imported water. The Forebay sites and conveyances rely on electrical equipment for power, to operate flow control structures, pumps, and to monitor these operations via the District's Supervisory Control and Data Acquisition (SCADA) system. The electrical equipment periodically requires preventative maintenance as prescribed in the NETA MTS specification and the NFPA 70B standard.

Agendize for April 17 Board meeting: Authorize issuance an agreement with ABM Electrical Power Services, LLC in the amount of \$54,650 for services to inspect, clean, test and certify 12 sites' power distribution equipment.

BACKGROUND/ANALYSIS

The District's surface water recharge program includes approximately 26 distinct facilities across approximately 1,600 acres. An annual average of 260,000 acre-feet of water percolates through the program's sites. The program includes 11 pump stations, 4 rubber dams, level and flow instrumentation, cameras, and a SCADA system. The electrical equipment used to power these devices and equipment requires periodic preventative maintenance and inspection to ensure its longevity and reliability. While staff performs these activities for lower voltage electrical equipment, the District outsources the work for medium voltage and 480-volt components. Sites containing this equipment includes the Burris Basin Pump Station, Anaheim Lake Pump Station, Kraemer-Miller Pump Station, Warner Basin Pump Station, Imperial Rubber Dam, Five Coves Rubber Dam, Field Headquarters, Weir #3, Weir #4, Miraloma Basin, La Palma Basin, and La Jolla Basin.

In November 2023, staff released a Request for Proposals (RFP) to qualified contractors with specific invitations to three firms. Two firms responded before the January deadline, see Table 1 for a summary of the proposal fees received. After review of the proposals and comparison of the fees, staff recommends awarding the scope of work to ABM Electrical Power Services, LLC in the amount of \$54,650.

WELLS AM-29A AND MCAS-10

SUMMARY

Bids for destruction of monitoring wells AM-29A and MCAS-10 were received on April 2, 2024. Staff recommends awarding the contract to the lowest responsive bidder BC2 Environmental LLC.

BACKGROUND/ANALYSIS

AM-29A

Monitoring well AM-29A was constructed by the Orange County Transportation Authority (OCTA) in 1992 to a depth of 97 feet. When constructed, OCTA named this well MW-1. This perched aquifer well was installed to investigate an underground storage tank leak on OCTA property. Attached Figure 1 shows the location of the well.

In 1999, OCWD and OCTA executed an agreement whereby OCWD accepted responsibility for the well and renamed it AM-29A. Between 1999 and 2017, OCWD used this well to monitor groundwater levels and quality in the North Basin area. OCWD stopped monitoring AM-29A in 2017 because no significant contamination had been detected in the well, and the well is too shallow to provide useful long-term groundwater level data for the regional Shallow Aquifer. For these reasons, staff has determined that the well should be properly destroyed and sealed.

MCAS-10

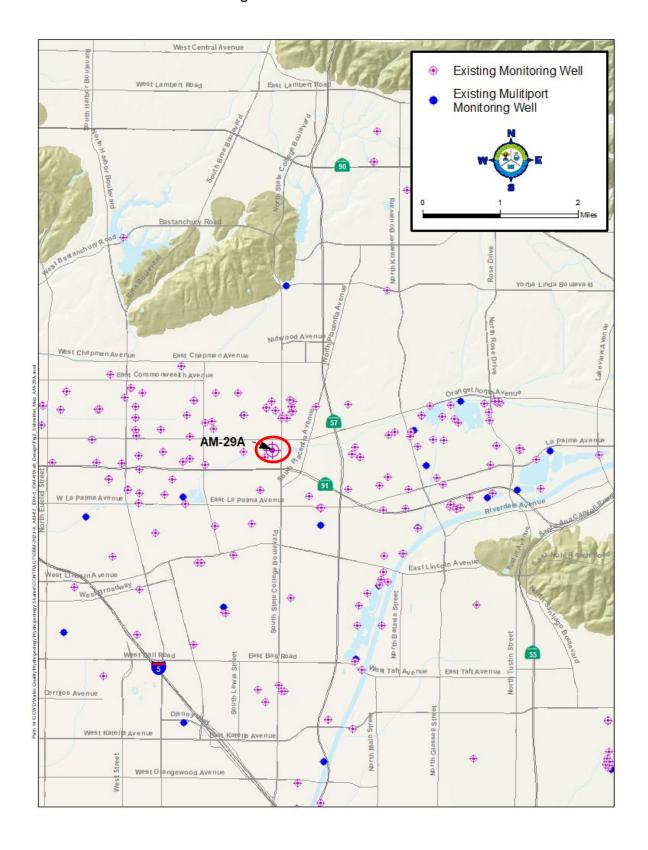
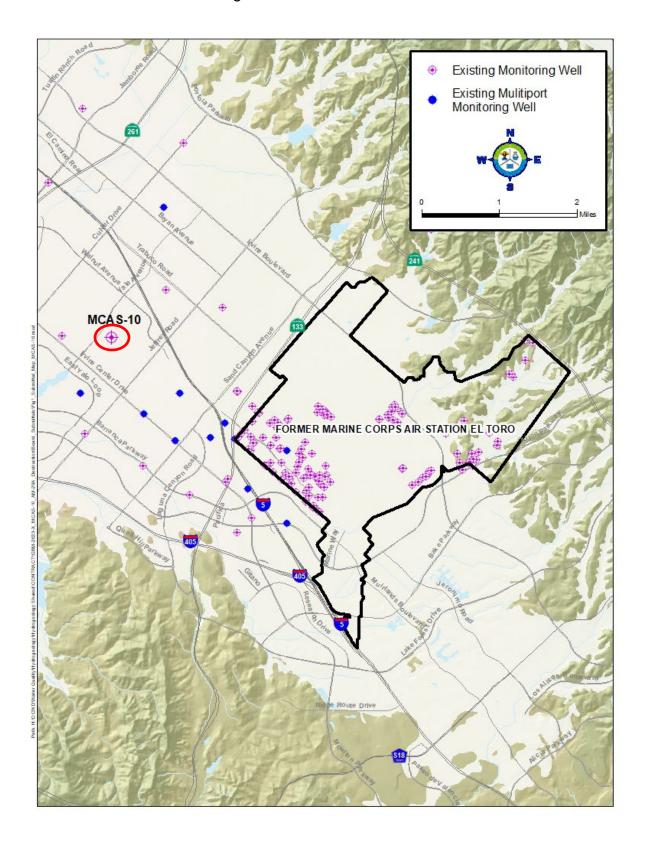


Figure 2: MCAS-10 Location

Monitoring well MCAS-10 was constructed by OCWD in 1989 to a depth of 389 feet to investigate the extent of the TCE plume that originated from the former Marine Corps Air Station El Toro and to characterize the local hydrogeology. Attached Figure 2 shows the location of MCAS-10. OCWD and the Department of the Navy (Navy) have used this well to monitor groundwater levels and quality. TCE has not been detected at well MCAS-10.

In recent years, OCWD staff observed that the well's purge rate during sampling has decreased appreciably to the point that the well draws down significantly and takes an inordinate amount of time to recover before a sample can be collected. Down-hole videos have shown that the mild steel well casing is heavily corroded and impacted by chemical and biological encrustation. An attempt by OCWD staff to redevelop the well was unsuccessful.

Based on the age, materials of construction, and field observations, staff has concluded that the well has reached the end of its useful life and should be properly destroyed and sealed. Navy staff agrees with our recommendation for destruction, and a replacement well is not currently proposed.

In July 2023, the Board authorized staff to issue a Notice Inviting Bids (NIB) for destruction of monitoring wells AM-29A and MCAS-10. The NIB for Contract GBM-2024-1 was issued on February 20, 2024. The following responsive bids were received on April 2, 2024:

BC2 Environmental, LLC	\$ 27,500
ABC Liovin Drilling, LLC	\$ 78,750
Arsenal Well Drilling Inc.	\$ 285,000

All bids are deemed responsive. The lowest responsive bid from BC2 Environmental LLC in the amount of \$27,500 is less than the geologist's estimate of \$45,000. Staff recommends awarding the contract to BC2 Environmental LLC.

Table 1 below summarizes the approved budget and anticipated expenditures. Anticipated project expenditures incorporating the recent bid show the project is expected to be completed within the approved budget.

Figure 1: AM-29A Location

ABOVEGROUND GASOLINE STORAGE TANK

SUMMARY

The underground gasoline storage tank located at Field Headquarters was removed in 2022. An agreement to procure and install an aboveground tank replacement was executed in September 2023. The execution of the project has taken longer than expected so the agreement term needs to be extended and the contractor is going to pay the permitting fees directly to expedite the process.

RECOMMENDATION

BACKGROUND/ANALYSIS

The 2,500 gallon gasoline underground storage tank (UST) located at Field Headquarters (FHQ) did not pass pressure tests in 2021. The Anaheim Fire & Rescue Hazardous Materials Section issued Correction Notices to the District requiring removal of the gasoline and tank. The District awarded a contract for removal of the UST and the scope was executed in the summer of 2022. No contamination was observed during the removal of the UST, nor detected in the soil samples analyzed by a third-party laboratory.

The gasoline tank and dispenser have been used at FHQ since the 1980's to supply gasoline for District vehicles and equipment under typical operations and as an emergency supply for potential disaster response. The on-site tank is a cost saving measure because the District can bulk purchase gasoline at a discounted rate.

An agreement for a new 1,000 gallon gasoline aboveground storage tank (AST) was issued in September 2023 to Falcon Services & Construction, Inc. The regulatory requirements for an AST are less stringent than a UST, and potential leaks can be immediately observed in the AST arrangement versus having to be indirectly tested for

with a UST arrangement. Permitting for the project has taken longer than anticipated and the original agreement term has expired. To expedite the permitting process, the payment of permitting fees is being shifted to the contractor instead of being paid directly by the District. Additionally, the bollards surrounding the tank have been changed to be removable, which is a cost increase for the tank installation. Staff recommends extending the agreement term through the end of the calendar year and increasing the agreement amount by \$17,923 to a total of \$115,492. The project's budget is shown in Table 1.

SUMMARY

BC2 Environmental, LLC, (BC2) has completed all work under Contract SG-2021-1 for the installation of 11 monitoring wells at five sites located in the cities of Seal Beach and Huntington Beach. The final contract cost was \$972,030, which is \$101,315 under the contracted amount and \$312,700 under the Board-approved budget.

RECOMMENDED BY COMMITTEE

Agendize for April 17 Board meeting: Accept completion of work and authorize filing a Notice of Completion for Contract SG-2021-1, Construction of Five Monitoring Well Clusters BS23 and BS25 through BS28.

BACKGROUND/ANALYSIS

OCWD has been actively investigating the nature and extent of seawater intrusion in the Sunset Gap since 2010, including the installation of nine multi-depth monitoring well clusters within the Naval Weapons Station Seal Beach (NWSSB).

In October 2020 the Board approved the staff's recommendation to install 11 additional clustered monitoring wells at five locations: one site in Seal Beach (BS25) and four in Huntington Beach (BS23, BS26, BS27 and BS28) (**Figure 1**). By January 2022, nine monitoring wells were constructed. In parallel, OCWD was in the process of obtaining a State Coastal Commission (Commission) development permit for a two-well cluster site (BS25) in the City of Seal Beach. However, Commission staff were not going to recommend approval of the permit due to concerns of the local Native American tribe. Consequently, OCWD decided to move well site BS25 from its original planned location to nearby NWSSB. OCWD staff obtained permission from NWSSB and in January

2024, after a two-year delay, monitoring wells BS25A and BS25B were successfully installed.

Change Orders 1 through 7 are described below and their costs are shown on Table 1. Change Orders 1 through 7 were executed under the General Manager's authority.

Change Order No. 1

This change order was for out-of-scope costs for sound panel installation and breakdown at well site BS27 that is located adjacent to a business office and required setup modifications to secure the panels on an existing sloped landscape. Costs also included landscape repairs. The increase to the contract was \$14,000.

Change Order No. 2

This change order was for out-of-scope costs for the implementation of a nuclear magnetic resonance (NMR) logging tool in borehole BS23B to augment lithologic resolution for interpretation. Saline groundwater can affect standard geophysical logs and result in a misinterpretation of the lithology. The NMR log provided detailed lithologic information regardless of formation salinity which greatly enhanced the geologic interpretation. The increase to the contract was \$3,300.

Change Order No. 3

This change order extended the contract completion schedule for an additional 100 days for delays beyond the Contractor's control and did not include a cost increase.

Change Order No. 4

This change order extended the contract completion schedule for an additional 290 days for delays beyond the Contractor's control and did not include a cost increase.

Change Order No. 5

This change order included:

- 1. Reduce Bid Item 27 by 50 hours, Well Development: -\$27,500.
- 2. Costs for out-of-scope work, including NWSSB security and access requirements (security clearances, badging of personnel, and preconstruction safety meeting with NWSSB personnel), and increased operating and materials costs due to the unanticipated one-year delay in the project.
- 3. The net increase to the contract was \$13,190.

Change Order No. 6

This change order included the following:

- 1. Increase cost of \$4,125 for NMR logging due to inflation during the unanticipated 1½-year delay in the project.
- 2. Extend contract completion schedule for an additional 185 days.

Change Order No. 7

Bid item adjustments were made to reconcile the original bid quantities with the actual quantities of work/materials completed/installed. Several large line-item reductions were identified under waste disposal, well development (mechanical, submersible pumping), and chemical development. All the well casings 'cleaned up' faster than anticipated, and chemical treatments were not deemed necessary during well development resulting in a total cost savings of about \$50,000. In addition, total drilling fluids and soil waste disposal charges were approximately \$39,000 less than originally estimated. The total of these adjustments resulted in a contract cost reduction of \$101,315.

BC2 has completed all work under Contract SG-2021-1. Staff recommends Board approval to accept completion of the work and authorize filing a Notice of Completion for Contract SB-2021-1.

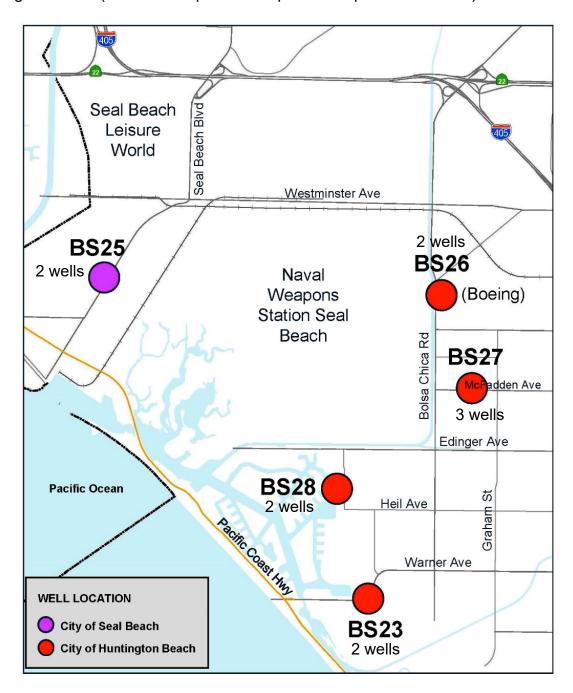

The IRWM Implementation Grant program is a unique funding program which requires project partnership and collaboration and multiple project benefits. The District has successfully obtained grant fundings from the IRWM Implementation Grant Program since its inception The District's PFAS groundwater treatment projects to be performed at Garden Grove well 19 and Santa Ana well 31 meet the IRWM Grant funding requirements and was awarded a Proposition 1 IRWM Implementation Grant in the amount of \$4,200,000.

GRANT FUNDING CONTRACT BETWEEN THE

SANTA ANA WATERSHED PROJECT AUTHORITY

AND

ORANGE COUNTY WATER DISTRICT

This Proposition 1 Round 2 Integrated Regional Water Management Program ("IRWMP") Implementation Grant Funding Contract ("Contract") is made between Santa Ana Watershed Project Authority ("SAWPA"), and Orange County Water District, (the "Sub-Grantee" or "OCWD"). SAWPA and the Sub-Grantee may be individually referred to as "Party", and collectively referred to as the "Parties".

WHEREAS, Section 79740 et seq. of the Water Code authorized approximately \$510 million to assist water infrastructure systems adapt to climate change, and to provide incentives for water agencies to collaborate in managing the region's water resources and setting regional priorities for water infrastructure, improve regional water self-reliance, and reduce reliance on the Sacramento-San Joaquin Delta;

WHEREAS, on January 10, 2024, the California Department of Water Resources ("DWR") and SAWPA entered into a Proposition 1 Round 2 Integrated Regional Water Management Implementation Grant Agreement No. 4600015418 ("Grant Agreement"), attached hereto as **Attachment A**, providing that SAWPA would serve as the program manager for the \$29,058,570 in IRWMP grant funds to be disbursed to certain Sub-Grantees including OCWD, consistent with IRWMP and California Environmental Quality Act ("CEQA") requirements, and ensuring that the maximum benefit of such funds are realized in the Santa Ana River Watershed; and

WHEREAS, consistent with the Grant Agreement, SAWPA intends to disburse to the Sub-Grantee a portion of the \$29,058,570 in IRWMP grant funds for its project component (as described in Section 1 below) by way of this Grant Funding Contract with the Sub-Grantee.

THEREFORE, based on the foregoing incorporated recitals and in consideration of the mutual covenants and conditions set forth in this Contract, the Parties hereby agree to the following:

SECTION 1. PROJECT DESCRIPTION

The Sub-Grantee's Project is the component described in the IRWMP Grant Agreement as **Orange Country PFAS Groundwater Treatment Program.** The project will install two ion exchange well-head treatments at Garden Grove Well 19 and Santa Ana Well 31 to remove Per-and Polyfluorinated Substances (PFAS). The treated groundwater from Wells 19 and 31 will be disinfected through an advanced treatment process of ion exchange and delivered to the existing drinking water distribution systems. The project will provide approximately 2,000 acrefeet per year of high-quality groundwater supply to the community and will help alleviate the negative impact of drought on Orange County water supplies.

SECTION 2. CONTRACT DOCUMENTS; ORDER OF PRECEDENCE; SUB-GRANTEE GENERAL COMMITMENT

This Contract incorporates and includes as part of its terms and conditions the Grant Agreement.

In the event of any inconsistency between this Contract and the Grant Agreement, except as otherwise specifically provided, the inconsistency shall be resolved by giving precedence to the Grant Agreement.

The Sub-Grantee shall comply with all terms, provisions, conditions, and commitments of this Contract and the Grant Agreement. Such compliance shall include providing SAWPA with all deliverables, budget detail, reports and all other documents required by the Grant Agreement.

On behalf of and for the benefit of SAWPA, Sub-Grantee shall comply with all of the obligations and requirements of the Grant Agreement as if the Sub-Grantee were the "Grantee" under the terms of the Grant Agreement. Such compliance shall be to the fullest extent necessary and as may be required by SAWPA in order to enable SAWPA to comply with the Grant Agreement as "Grantee."

SECTION 3. ESTIMATED ELIGIBLE PROJECT COSTS; GRANT AMOUNT

The estimated reasonable cost of the Project at the time of SAWPA's and DWR's approval of the Project is **Eleven Million One Hundred Thousand** dollars (\$11,100,000). Subject to all of the terms, provisions, and conditions of this Contract, and subject to the availability of the grant funds, SAWPA shall disburse such grant funds in a sum not-to-exceed **Four Million Two Hundred Thousand** dollars (\$4,200,000). In all events, SAWPA's actual grant disbursements to the Sub-Grantee under this Contract shall not exceed payments received from the DWR.

If the Sub-Grantee proceeds to construction of such facilities, the final grant amount will be determined in accordance with the provisions of this Contract. If the Sub-Grantee fails or refuses to proceed with or complete the construction of facilities, SAWPA shall consider such failure or refusal to be a material violation and breach of this Contract. SAWPA shall have all rights and remedies as are otherwise available to it for breach of this Contract by the Sub-Grantee.

If actual Project costs exceed the Project's estimated reasonable cost, SAWPA shall have no obligation to provide grant funds for such exceedance.

Eligible Project costs include the reasonable costs of studies, engineering, design, land and easement acquisition, legal fees, preparation of environmental documentation, environmental mitigations, monitoring, project construction, and any other task set forth in Exhibit A of the Grant Agreement.

Reimbursable administrative expenses are the necessary costs incidental but directly related to the Project.

Costs not eligible for reimbursement or not eligible to be counted as local match include, but are not limited to:

- Costs for work performed before the dates specified below.
- Costs for preparing and filing a grant application

- Operation and maintenance costs, including post-construction performance and monitoring costs.
- Purchase of equipment that is not an integral part of the Project.
- Establishing a reserve fund.
- Purchase of water supply.
- Replacement of existing funding sources for on-going programs.
- Support of existing agency requirements and/or mandates.
- Purchase of land in excess of the minimum required acreage necessary to operate as an integral part of the Project, as set forth and detailed by engineering and feasibility studies, or acquisition of land by eminent domain.
- Overhead and indirect costs not directly related to Project costs, such as generic overhead or markup.
- Travel costs and per diem costs, unless allowed under Exhibit D, Item 46 of the Grant Agreement.
- Mitigation for environmental impacts not resulting from implementation of the Project funded by this program.

Work performed after January 1, 2015, is eligible to be counted as local match. Work performed after May 5, 2023, is eligible for grant reimbursement.

SECTION 4. SCOPE OF WORK AND COMPLETION OF PROJECT

The Scope of Work is described in Exhibit A of the Grant Agreement. The Parties understand that time is of the essence and agree to expeditiously proceed with and complete the Project.

SECTION 5. DISBURSEMENT

Grant funds will be disbursed in accordance with the disbursement provisions of the Grant Agreement. SAWPA will disburse grant funds received from DWR to Sub-Grantee within 30 days of receipt of grant funds, except as described in *Section 14. Withholding of Grant Disbursements* of this Contract.

Retention is stipulated in Exhibit D, Item 36 of the Grant Agreement.

SECTION 6. <u>FISCAL MANAGEMENT SYSTEMS AND ACCOUNTING STANDARDS</u>

The Sub-Grantee agrees that, at a minimum, its fiscal control and accounting procedures shall be sufficient to permit tracking of grant funds to a level of expenditure adequate to establish that such funds have not been used in violation of State law or this Contract. The Sub-Grantee shall maintain separate Project accounts in accordance with generally accepted accounting principles and practices, consistently applied.

SECTION 7. TERM

This Contract shall not be effective until it has been fully executed by both parties. The Term of this Contract shall be the same as the Term of the Grant Agreement, unless sooner terminated pursuant to the provisions of this Contract or the Grant Agreement.

SECTION 8. COVENANT TO OPERATE AND MAINTAIN PROJECT FACILITIES

The Sub-Grantee or its designee shall properly staff, operate and maintain all portions of the Project during the Project's useful life and in accordance with this Contract, the Grant Agreement, and all applicable state and federal laws, rules and regulations. In the event that the Sub-Grantee

assigns or transfers all or any portions of the Project to another entity, the Sub-Grantee shall be responsible to ensure that the assignee or transferee of all or any portions of the Project shall properly staff, operate and maintain all portions of the Project during its useful life and in compliance with this Contract, the Grant Agreement, and all applicable state and federal laws, rules and regulations. The Parties to this Contract understand and agree that this covenant shall survive the expiration or termination of this Contract. The Parties further understand and agree that this covenant is for the benefit of SAWPA and DWR and shall be enforceable during the useful life of the Project facilities.

Sub-Grantee shall prepare and maintain the Project Performance Monitoring Plan ("PPMP") required by the Grant Agreement. DWR and SAWPA shall approve the PPMP prior to the disbursement of grant funds for construction or monitoring activities.

Sub-Grantee shall not abandon, substantially discontinue use of, lease, or dispose of the Project, including its construction, or any significant part or portion thereof, during the useful life of the Project without SAWPA's and DWR's prior written approval.

SECTION 9. ASSIGNMENT

Neither this Contract, nor any duties or obligations under this Contract, nor any of the Project facilities referenced in this Contract shall be assigned by any Party without the prior written consent of the other Party.

Should an assignment or transfer occur, whenever SAWPA or the Sub-Grantee are named or referred to herein, such reference shall be deemed to include the successor to the powers, duties and functions that are presently vested in SAWPA and the Sub-Grantee, and all Contract and covenants required hereby to be performed by or on behalf of SAWPA and/or the Sub-Grantee shall bind and inure to the benefit of the respective successors thereof whether so expressed or not.

SECTION 10. COMPLIANCE WITH LAWS AND REGULATIONS

The Sub-Grantee agrees that it shall, at all times, comply with and require its contractors and subcontractors to comply with all applicable federal and state laws, rules, regulations and guidelines. The Sub-Grantee shall comply with, implement, and fulfill all environmental mitigation measures applicable to the Project, and which may otherwise be required by this Contract and the IRWMP Grant Agreement, the California Environmental Quality Act ("CEQA"), and the State CEQA Guidelines.

SECTION 11. ACKNOWLEDGEMENT OF CREDIT/SIGNAGE REQUIREMENTS

Sub-Grantee shall include appropriate acknowledgement of credit to the State, SAWPA and to all cost-sharing partners for their support when promoting the Project or using any data and/or information developed under this Sub-Grantee Agreement. Signage shall be posted in a prominent location at the Project Site(s), if applicable, or at the Sub-Grantees headquarters and shall include the following disclosure statement: "Funding for this project has been provided in full or in part from the Water Quality, Supply, and Infrastructure Improvement Act of 2014 and through an agreement with the State Department of Water Resources and by the Santa Ana Watershed Project Authority". The sign shall include the Department of Water Resources logo, One Water One Watershed logo and the SAWPA logo (available from SAWPA). Before it is constructed, the Sub-Grantee shall provide the draft design layout of the sign to SAWPA for approval. Sub-Grantee shall notify SAWPA that the sign has been erected by providing a site

map with the sign location noted and a photograph of the sign.

SECTION 12. CONSTRUCTION ACTIVITIES AND NOTIFICATION

The Sub-Grantee shall immediately notify SAWPA in writing of:

- (1) Any substantial change in the scope, budget, or work performed on the Project. The Sub-Grantee agrees that no substantial change in the scope of the Project may be undertaken until written notice of the proposed change has been provided to SAWPA, and SAWPA and DWR have given written approval for such a change;
- (2) Any public or media event publicizing the accomplishments and/or results of this Grant Agreement shall provide the opportunity for attendance and participation by SAWPA and DWR. Sub-Grantee must notify SAWPA at least 20 calendar days prior to the event.
- (3) Unscheduled cessation of all major construction work on the Project where such cessation of work is expected to or does continue for a period of 30 calendar days or more;
- (4) Any circumstance, combination of circumstances, or condition which is expected to delay project completion for a period of 90 calendar days or more beyond the initial estimated date of completion of the Project previously provided to SAWPA;
- (5) Completion of construction of the Project and provide SAWPA and DWR the opportunity to participate in the inspection. Sub-Grantee must notify SAWPA at least 20 calendar days prior to final inspection.

SECTION 13. PAYMENT OF PROJECT COSTS

The Sub-Grantee shall provide for and make payment for all Project costs. All costs and payments for the Project shall be paid by the Sub-Grantee promptly and in compliance with all applicable laws. All grant disbursements will be reimbursements.

SECTION 14. WITHHOLDING OF GRANT DISBURSEMENTS

SAWPA may withhold all or any portion of the grant funds provided for by this Contract in the event that:

- (1) The Sub-Grantee has violated, or threatens to violate, any term, provision, condition, or commitment of this Contract;
- (2) The Sub-Grantee fails to maintain reasonable progress toward completion of the Project; or
 - (3) DWR directs SAWPA to withhold any such grant funds.

SECTION 15. <u>INVOICING</u>

- (A) Invoices shall be completed on a State-provided invoice form and shall meet the following format requirements:
- (1) Invoices must contain the date of the invoice, the time period covered by the invoice, and the total amount due.

- (2) Invoices must be itemized. The amount claimed for salaries/wages/consultant fees must include a calculation formula (i.e. hours or days worked times the hourly or daily rate = the total amount claimed).
- (3) Sufficient evidence (i.e. receipts, copies of checks, timesheets) must be provided for all costs included in the invoice.
- (4) Each invoice shall clearly delineate those costs claimed for reimbursement from the State's grant amount and those costs that represent the Sub-Grantee's share as applicable.
- (B) Invoices also shall include the following information:
- (1) Costs incurred for work performed in implementing the IRWM program or program contracts during the period identified in the particular invoice.
- (2) Costs incurred for any interests in real property (land or easements) that have been necessarily acquired for the Project during the period identified in the particular invoice for the construction, operation, or maintenance of the Project.
 - (3) Appropriate receipts and reports for all costs incurred.

SECTION 16. RECORDS AND REPORTS

- (A) Without limitation on the requirement that Project accounts be maintained in accordance with generally accepted government accounting standards, the Sub-Grantee shall comply with the records and reporting requirements imposed by the IRWMP Grant Agreement, and shall also:
- (1) Establish an official Project file that documents all significant actions relative to the Project;
- (2) Establish separate accounts that adequately and accurately itemize and describe all amounts received and expended on the Project, including all grant funds received under this Contract:
- (3) Establish separate accounts that adequately and accurately itemizes and describes all income received which is attributable to the Project, specifically including any income attributable to grant funds disbursed under this Contract;
- (4) Establish an accounting system that adequately and accurately itemizes and describes final total costs of the Project, including both direct and indirect costs;
- (5) Establish such accounts and maintain such records as may be necessary for the State, DWR and SAWPA to fulfill federal reporting requirements, including any and all reporting requirements under federal tax statutes or regulations; and
- (6) If Force Account is used by the Sub-Grantee for any phase of the Project, establish an account that adequately and accurately itemizes and describes all employee hours, and associated tasks charged to the Project per employee.

- (B) The Sub-Grantee shall require all Project contractors and subcontractors to maintain books, records, and other material relative to the Project in accordance with generally accepted accounting standards, and to require that such contractors and subcontractors retain such books, records, and other material for a minimum of five (5) years after the Grant Agreement termination date. The Sub-Grantee shall require that such books, records, and other material shall be subject, at all reasonable times, to inspection, copying, and audit by SAWPA, DWR or their authorized representatives.
- (C) The Sub-Grantee shall maintain its books, records and other material concerning the Project in accordance with generally accepted government accounting standards and as required by the IRWMP Grant Agreement.
- (D) All documents required or requested to be provided to SAWPA shall be submitted electronically in the both the native format (e.g. Microsoft Word, Microsoft Excel, etc) and PDF. All documents shall be public domain or the property of SAWPA once submitted.
- (E) The Sub-Grantee agrees to expeditiously provide, during work on the Project and for three years after the projection completion, such reports, data, information and certifications as may be reasonably required by SAWPA or DWR. Such documents and information shall be provided in electronic format.

SECTION 17. QUARTERLY PROGRESS REPORTS

Quarterly Progress Reports shall be completed using the templates provided. Quarterly Progress Reports shall provide a brief description of the work performed, activities, milestones achieved, any accomplishments as well as any problems encountered in the performance of the work. The first quarterly report shall be submitted no later than the 30th of the month following the end of the reporting period. The first progress report shall cover the following reporting period: January 2, 2015 (or project start, if later) to March 31, 2024, and will be due to SAWPA on April 30, 2024. Subsequent progress reports will be due as follows: Jan-Mar reporting period – due Apr 30; Apr-Jun reporting period – due Jul 31; Aug-Sep reporting period – due Oct 31; Oct-Dec reporting period – due Jan 31.

SECTION 18. PROJECT REVIEW AND EVALUATION; FINAL REPORTS AND AUDIT

- (A) SAWPA may perform a project review or otherwise evaluate the project to determine compliance with the contract documents at any time or if questions about the proper use or management of the funds arise. SAWPA may review or evaluate the contractor or vendor for compliance with the terms and conditions of the contract documents. The project review and evaluation may be performed by SAWPA or may be contracted to a responsible third party. Any findings and recommendations of the project review and evaluation shall be addressed by the Sub-Grantee within 60 days of the date such findings and recommendations are provided to the Sub-Grantee and before the next invoice is paid by SAWPA.
- (B) Inventory of equipment purchased with grant funds.
- (1) At least 75 days prior to submission of the final project invoice, Sub-Grantee shall consult with SAWPA on the scope of the inventory of equipment purchased with grant funds. This inventory shall include all items with a current estimated fair market value of more than \$5,000 per item.

- (2) At least 45 days prior to submission of the final project invoice, Sub-Grantee shall provide SAWPA with a final inventory list of equipment purchased with grant funds. DWR shall have the opportunity to take title to any item on the inventory list. Should DWR take title to any item on the inventory list, DWR shall arrange for delivery and transportation of such inventory.
- (C) In addition to the documents and deliverables required to be provided by the IRWMP Grant Agreement, within 90 days after completion of the Project but no later than 14 days prior to the due date indicated in the IRWMP Grant Agreement, the Sub-Grantee shall provide to SAWPA, a Project Completion Report. The Project Completion Report shall follow the Guidelines in Exhibit F of the Grant Agreement.
- (D) SAWPA may call for an audit of financial information relative to the Project, where SAWPA determines that an audit is desirable to assure program integrity or where such an audit becomes necessary because of federal or state requirements. Where such an audit is called for, the audit shall be performed by a Certified Public Accountant independent of the Sub-Grantee and at the cost of the Sub-Grantee. The audit shall be in the form required by SAWPA.

SECTION 19. PROJECT CLOSEOUT DOCUMENTATION

To ensure that that the Project is closed out in a manner that provides an auditable file for SAWPA, Sub-Grantee shall follow a close-out procedure that includes payment of all subcontracts, completion of all punch lists, defects correction, satisfaction of warranty or guarantee issues, and any other requirements for the completion of the scope of work. Such close-out procedures shall include those procedures contained in the IRWMP Grant Agreement or otherwise required by SAWPA and DWR.

SECTION 20. <u>POST-PERFORMANCE REPORTS</u>

Post-Performance Reports shall be submitted to SAWPA within 75 calendar days after the first operational year of the Project has elapsed. This record keeping and reporting process shall be repeated annually for a total of three (3) years after the completed project begins operation.

SECTION 21. MONITORING REQUIREMENTS

- (A) All groundwater projects and projects that include groundwater monitoring requirements are consistent with the Groundwater Quality Monitoring Act of 2001.
- (B) Projects that affect water quality shall include a monitoring component that allows the integration of data into statewide monitoring efforts, including where applicable, the Surface Water Ambient Monitoring Program administered by the State Water Resources Control Board.
- (C) Groundwater quality and ambient surface water quality monitoring data that include chemical, physical, or biological data shall be submitted to the State with a narrative description of data submittal activities (included in project reports) as described below:
- (1) Surface water quality monitoring data shall be prepared for submission to the California Environmental Data Exchange Network (CEDEN). CEDEN data templates are available on the CEDEN website (http://www.ceden.org). Inclusion of additional data elements described on the data templates is desirable. Data ready for submission should be uploaded to the CEDEN Regional Data Center via the CEDEN website and a copy shall be given to SAWPA.

- (2) If Sub-Grantee's Work Plan contains a groundwater ambient monitoring element, groundwater quality monitoring data shall be submitted to the State for inclusion in the State Water Resources Control Board's Groundwater Ambient Monitoring and Assessment (GAMA) Program. Information on the GAMA Program can be obtained at http://www.waterboards.ca.gov/water_issues/programs/gama. If further information is required, the Sub-Grantee can contact the State Water Resources Control Board GAMA Program. A copy of all data submitted shall be given to SAWPA.
- (D) If groundwater level data is collected, Sub-Grantee must submit this data to DWR's Water Data Library (WDL) with a narrative description of data submittal activities (included in project reports). Information regarding the WDL and the format to submit the data in can be found at: http://wdl.water.ca.gov/. A dopy of all data submitted shall be given to SAWPA.

In the near future, DWR's WDL will be replaced by the California Statewide Groundwater Elevation Monitoring program (CASGEM). Once this program comes online, Sub-Grantee will then submit groundwater level data to CASGEM. Information regarding the CASGEM program can be found at: http://www.water.ca.gov/groundwater/casgem/.

SECTION 22. TERMINATION; IMMEDIATE REPAYMENT; INTEREST

- (A) SAWPA may terminate this Contract at any time prior to completion of the Project for Sub-Grantee's violation of any provision of this Contract upon written notice by SAWPA of the violation and the failure of Sub-Grantee to come into compliance within a reasonable time as established by SAWPA.
- (B) In the event of such termination, the Sub-Grantee agrees, upon demand, to immediately repay to SAWPA an amount equal to the amount of grant funds disbursed to the Sub-Grantee prior to such termination. In the event of termination, prejudgment interest shall accrue on all amounts due from the date that notice of termination is mailed to the Sub-Grantee to the date of full repayment by the Sub-Grantee.
- (C) SAWPA may terminate this Contract should DWR terminate SAWPA as program manager or terminate funding for this Contract or the Project or should DWR terminate its standard agreement with SAWPA on this Project. Upon such DWR-caused termination, SAWPA shall not be liable to Sub-Grantee for any damages, costs or expenses resulting from such termination.

SECTION 23. DAMAGES FOR BREACH AFFECTING TAX EXEMPT STATUS

In the event that any breach of any of the provisions of this Contract or other action by the Sub-Grantee shall result in the loss of tax exempt status for any bonds, or if such breach shall result in an obligation on the part of the SAWPA to reimburse the federal government by reason of any arbitrage profits, the Sub-Grantee shall immediately reimburse SAWPA and/or DWR in an amount equal to any damages paid by or loss incurred by the State due to such breach.

SECTION 24. ARBITRATION

Any dispute which may arise under this Contract by and between the SAWPA and the Sub-Grantee, including the Sub-Grantee's subcontractors, laborers, and suppliers, shall be submitted to binding arbitration pursuant to the Construction Industry Arbitration Rules and Mediation Procedures of the American Arbitration Association (AAA). The arbitrator shall decide

each and every dispute in accordance with the laws of the State of California and AAA rules, and all other applicable laws. Unless the Parties stipulate in writing to the contrary, prior to the appointment of the arbitrator, all disputes shall first be submitted to non-binding mediation.

SECTION 25. COSTS AND ATTORNEY FEES

In the event of arbitration or litigation between the parties hereto arising from this Contract, it is agreed that each party shall bear its own costs and attorney fees.

SECTION 26. WAIVER

Any waiver of any rights or obligations under this Contract or the IRWMP Grant Agreement shall be in writing and signed by the Party making such waiver, and approved by SAWPA and the DWR.

SECTION 27. <u>AMENDMENT</u>

This Contract may be amended at any time by mutual written agreement of the Parties and the DWR.

SECTION 28. SAWPA REVIEWS; SUB-GRANTEE AS INDEPENDENT CONTRACTOR

- (A) The Parties agree that review or approval of the Project or Project plans and specifications by SAWPA is for administrative and eligibility purposes only and does not relieve the Sub-Grantee of its responsibility to properly plan, design, construct, operate, and maintain the Project. As between SAWPA and the Sub-Grantee, the Sub-Grantee agrees that it has sole responsibility for proper planning, design, construction, operation, and maintenance of the Project.
- (B) The Sub-Grantee is an independent contractor exclusively responsible for the design, construction, operation and maintenance of the specific project funded by this Grant Funding Contract and that the Sub-Grantee is not acting as SAWPA's agent, nor is SAWPA acting as an agent of the Sub-Grantee.

SECTION 29. INDEMNIFICATION

- (A) The Sub-Grantee shall defend, indemnify and hold and save SAWPA and DWR and their directors, commissioners, officers, employees, agents and assigns (collectively the "Indemnified Parties") free and harmless from any and all liabilities for any claims and damages (including inverse condemnation) that may arise out of the Project and the Grant Agreement, including but not limited to any claims or damages arising from planning, design, construction, maintenance, and/or operation of this Project and any breach of this Agreement. The Sub-Grantee shall require its contractors or subcontractors to name SAWPA, the State, its officers, agents and employees as additional insureds on their liability insurance for activities undertaken pursuant to this Sub-Agreement.
- (B) The Sub-Grantee understands and agrees that it has complied and will comply with CEQA and the State CEQA Guidelines for the project which is the subject matter of this Grant Funding Contract. Sub-Grantee understands and agrees that it is ultimately and solely responsible, as the lead agency, for compliance with CEQA and any mitigation measures

required for the Project. The Sub-Grantee hereby agrees to indemnify, defend and hold harmless SAWPA and the DWR from any and all claims or actions related to this Project that may be made by any third party or public agency alleging, among other things, violations of CEQA or the State CEQA Guidelines.

(C) The Sub-Grantee shall ensure that adequate insurance coverage is provided by Sub-Grantee and/or its contractors and subcontractors on the Project funded, in part, by this Contract. Such insurance shall include adequate coverage for comprehensive commercial general liability, business auto liability, workers compensation liability, professional and errors and omissions liability, property insurance, including all builders risk insurance. Such insurance coverage shall, at a minimum, insure against injuries to third parties, damage to property owned by third parties, physical damage to the Project and all related facilities, theft of building materials and supplies intended for the Project, delays in Project completion, delays in Project Completion due to strikes and governmental actions, liquidated damages, employee injuries and work-related illnesses, design errors resulting in increased project costs, environmental damage caused by construction activities related to the Project, and nonperformance by the contractors and subcontractors. Such insurance coverages shall be provided by admitted insurance companies authorized to do business in the State of California, and with a minimum "Best's Insurance Guide" rating of "A:VII".

SECTION 30. PROJECT AND INFORMATION ACCESS

The Sub-Grantee agrees to ensure that SAWPA, DWR, or any authorized representative thereof, shall have reasonable access to the Project site at all reasonable times during Project construction, and thereafter for the useful life of the Project.

SECTION 31. OPINIONS AND DETERMINATIONS

Where the terms of this contract provide for action to be based upon the opinion, judgment, approval, review, or determination of either party hereto, such terms are not intended to be and shall never be construed as permitting such opinion, judgment, approval, review, or determination to be arbitrary and capricious.

Subject: AUTHORIZE PURCHASE ORDER TO BENDER CCP FOR REPAIR OF FIVE

RO HIGH PRESSURE FEED PUMPS

SUMMARY

The reverse osmosis (RO) treatment process used in the Groundwater Replenishment System (GWRS) Advanced Water Purification Facility (AWFP) contains 27 individual five million gallon per day (mgd) RO units. Each RO unit contains a one thousand horsepower high pressure feed pump. During the current installation of replacement RO membranes damage was found with five high pressure feed pumps that require repairs.

RECOMMENDATION

RECOMMENDED BY COMMITTEE

Agendize for April 17 Board meeting: Authorize issuance of a purchase order to Bender CCP in the amount of \$297,461 for repair of five reverse osmosis high pressure feed pumps for RO units F02, F03, G01, G02 and G03 and establish a total project budget of \$500,000.

BACKGROUND/ANALYSIS

The GWRS RO treatment facility consists of 27 RO units each capable of producing 5-mgd with one unit in reserve. There are 15 original RO units in operation since 2008, six that were added in 2015 as part of the GWRS Initial Expansion, and six additional units added as part of the recently completed GWRS Final Expansion. Each unit contains an individual one thousand horsepower vertical turbine pump. This pump provides the necessary pressure to force microfiltered water through the RO membranes within the unit. Recently a large RO membrane replacement project budgeted in fiscal year 2023-2024 for nine units that make up RO trains E, F, and G was started. The first unit whose membranes were removed for replacement was F01. Upon removal of the RO membrane vessel end caps the presence of carbon shavings was found on the first stage membranes. This was a sign that the carbon bearings within the vertical turbine high pressure feed pump had deteriorated and broke apart within the pump barrel and pumped into the vessels.

Upon removal of the high pressure feed pump it was discovered that one of the carbon bearings had totally deteriorated and another partially deteriorated. In response emergency repairs were made to the pump using the pump manufacturer's local service representative company, DXP Enterpises, Inc at a cost of \$98,000. As membrane installation has continued on RO units F02, F03, G01, G02, and G03 the presence of carbon shavings was also present as found in unit F01.

All five of the pumps for these RO units are also manufactured by FlowServe, like the pump for F01. All six pumps that make up the units in RO trains F and G were supplied in 2014 as part of the GWRS Initial Expansion project. These pumps are four stage vertical turbine pump with stainless steel components and contains several carbon bearings (one per bowl and one at the stuffing box). Staff suspects all five pumps will require similar repairs to those made on RO unit F01 earlier this year.

In order to get pricing for repairs to all five pumps a request for proposals (RFP) document was developed by staff in order for local, reputable pump repair firms to bid on cost to remove and repair the pumps. The RFP includes inspection of key pump components (impellers, bowls, stuffing box, shaft) and replacement of all bearings with an alternative material in lieu of carbon, replacement of all seals. The RFP also requires that only one pump be removed at a time for repairs to limit effects on GWRS production flow rates. The proposals assume a base level of effort to replace key pump components. The actual extent of repairs can't be known until the pumps are physically removed and inspected at a certified pump repair facility. A site job walk was held with prospective bidders recently and bids received. Below is a summary of the prices received per the scope of work in the RFP.

Staff recommends approval of a purchase order to Bender CCP in the amount of \$297,461 to repair RO high pressure pumps F02, F03, G01, G02, and G03 using funds from the current R&R fund R23008. The Bender CCP proposal is slightly less than that proposed by PAMCO and the proposed schedule is far superior. The proposed schedule by PAMCO is far too long and is due to the much smaller size of their machine shop repair facility.

R&R fund R23008 is set up to cover unforeseen large cost repairs or replacement of equipment within the GWRS, Green Acres Project, and Fountain Valley building campus. The expense for the repairs to these five pumps would come from R&R account R23008. Staff is recommending authorization of a purchase order to Bender CCP in the amount of \$297,461 and establish a total budget for this effort of \$500,000.

The extent of actual repairs required on each of the five pumps can't be estimated until the pumps are actually removed from service and inspected at a certified repair shop. For this reason staff is recommending a total budget of \$500,000 to account for additional expenses

should damage to the pumps be greater than anticipated. RO high pressure pump F01 which was repaired earlier this year on an emergency basis for the same issues for a total cost of \$98,000. It is for this reason staff is recommending a total budget of \$500,000 to cover cost of potential additional repairs for all five pumps.

AMERICA FOR THE SUPPLY AND DELIVERY OF LIME

SUMMARY

Lhoist North America has been supplying hydrated lime for the past few years. In March 2018, a Request for Proposals was issued to five vendors for the supply and delivery of hydrated lime for the GWRS and two proposals were received. At that time Lhoist North America submitted the lowest cost proposal. Current pricing was requested from Lhoist North America to extend the agreement for an additional 14 months and they have proposed a price of \$448.16/ton.

Agendize for April 17 Board Meeting: Authorize issuance of Amendment No.4 to Agreement No.1298 with Lhoist North America for the supply and delivery of hydrated lime at the rate of \$448.16 per ton for a period of 14 months.

BACKGROUND/ANALYSIS

The GWRS treatment process requires several chemicals that are delivered in bulk, one of which is hydrated lime. OCWD staff has been using a higher purity hydrated lime provided by Lhoist North America for several years. To date the higher purity product has been very positive and has reduced the amounts of inert solids that accumulate in the GWRS lime post treatment process. It has also led to reduced fouling of the District's seawater intrusion barrier and mid-basin injection wells.

The District installed the Tekkem lime system as an upgrade for the GWRS Initial Expansion project. This new lime system allows the lime to be more thoroughly mixed and aged before going to the saturators to stabilize the GWRS final product water. This significantly helped to produce more stable final product water by allowing more lime to

be dissolved to help increase alkalinity. In addition, Lhoist is able to provide a higher purity lime product that works well with the Tekkem lime delivery system. The use of the higher purity hydrated lime will also enhance the overall operation of the GWRS final product water stabilization process.

Lhoist North America has agreed to supply lime for an additional 14 months from May 1, 2024 to June 30, 2025 at a fixed price of \$448.16 per ton. The increase in price is due to a price increase in the high purity hydrated lime and the increase in the cost of transportation.

Lhoist is a family-owned business and has provided excellent service over the last few years. The high purity lime works well for the GWRS. Deliveries are on time, response time is minimal, and the billing is accurate. Staff recommends extending the Agreement with Lhoist for an additional 14 months.

Subject: ADDITIONAL FUNDS FOR WATER PRODUCTION R&R FUND 23008

SUMMARY

The Water Production department maintains a Refurbishment and Replacement (R&R) fund account R23008 for unforeseen GWRS, GAP, and Fountain Valley campus building, electrical, structural and mechanical repairs. This account requires replenishment for the current fiscal year due to unforeseen additional expenses.

RECOMMENDATION

RECOMMENDED BY COMMITTEE

Agendize for April 17 Board meeting: Authorize issuance of additional funds in the amount of \$800,000 to the Water Production Refurbishment and Replacement account R23008.

BACKGROUND/ANALYSIS

The Water Production department is responsible for all operations and maintenance of GWRS, GAP as well as the Fountain Valley campus facilities. In order to account for unforeseen equipment failures or planned equipment replacements an R&R funding account is set aside each fiscal year for these expenditures. The R&R account set aside for these expenditures for fiscal year 2023-2024 is known as R23008 and was funded in the amount of \$500,000 in the current fiscal year. As of March 2024, completed and planned expenditures for this account have left this account overdrawn by approximately \$103,000.

The main reason for the budget being expended prior to the end of the fiscal year has been unplanned refurbishment of a few key items with a large cost to fix or replace. One of those items is the failure of the main electrical cable that feeds power to seawater intrusion barrier wells I-29 to I-32. This failure occurred in August 2023. The cable was installed as part of the original GWRS construction in 2007. The main feeder power cable to these wells was found to be damaged and non-functional. In order to replace the cable an emergency repair was needed that required replacement of several hundred feet of electrical cable that necessitated two separate full lane closures in both Ellis Avenue and Beach Boulevard on two occasions. The total cost of the repair was \$107,000.

A second unexpected refurbishment item includes RO high pressure pump F01. This pump was found to have failed bearings that were discovered upon installation of new

membranes in unit F01 in December 2023. This pump ended up requiring all new bearings, seals, and a new shaft to be manufactured. The total cost of the effort to repair this pump was \$103,000.

A third unexpected expense was the requirement by California Division of Drinking Water (DDW) to require more precise online monitoring of peroxide residuals to the GWRS ultraviolet light advanced oxidation process (UV/AOP) as part of the revised operating permit conditions for the GWRS Final Expansion (GWRFE). This necessitated the procurement of a new style peroxide analyzer from the Hach Company to replace the existing Prominent brand online analyzer. The Hach analyzer will allow for more precise measurement of peroxide residuals while being more accurate in the presence of chloramines. The cost of this new online peroxide analyzer was \$38,000.

A fourth unexpected expense to highlight was the replacement of the sodium hypochlorite transfer pumps. The GWRS contains two large centrifugal pumps to allow transfer of sodium hypochlorite between storage tanks to evenly distribute chemical deliveries. The original transfer pumps experienced shaft and bearing failures whose repairs would have been nearly equivalent to the pump replacement costs. Both pumps are over 16 years old and the decision was made to replace both at a total cost of \$35,000.

Finally, as part of the planned RO membrane replacement project for RO trains F and G (containing a total of six, 5 mgd units) that occurred during the months of December 2023 and January 2024 it was discovered that all six units showed signs of failed or deteriorated high pressure pump carbon bearing material inside the pressure vessels. This indicates that the carbon bearing has likely partially or fully failed in multiple locations along the shaft of the high pressure pumps. All of the pumps that make up the six RO units of Trains F and G were supplied in 2014 as part of the GWRS Initial Expansion construction project. As stated earlier the high pressure pump for RO unit F01 has already been repaired using funding from R23008 with all bearings replaced with a new non-carbon material. Staff has now issued a request for proposal to have pump repair firms remove and repair as needed the five other pumps in units F02, F03, G01, G02, and G03. The expense for these repairs is intended to come from R&R account R23008 and is estimated at up to \$500,000.

In order to replenish R&R fund R23008 to account for any unanticipated repairs until the end of the FY23-24 additional funds are required. This includes funding for the planned repairs of five additional high pressure RO feed pumps showing signs of failed carbon bearings. Staff is requesting additional funds in the amount of \$800,000 to ensure that the R23008 account is properly funded until the end of the current 2023-2024 fiscal year.

DISCUSSION

The proposed budget has been reviewed in detail with the Board and Groundwater Producers over the past two months. The budget is based upon setting a Basin Production Percentage (BPP) of 85% and a Replenishment Assessment (RA) of \$688/acre-feet (af). Since the budget was first submitted to the Board on March 6, 2024, two changes have been made which do not impact the recommended RA as follows.

- Increase of \$1,500 to the General Fund budget for the updated cost of District memberships and sponsorships for Sustain OC Foundation in department 1010 – General Manager's Office.
- 2. Increase of \$25,000 to the General Fund budget for the updated cost of District special department expense for the Future Water Demand Study in department 1044 Planning and Watershed Management.

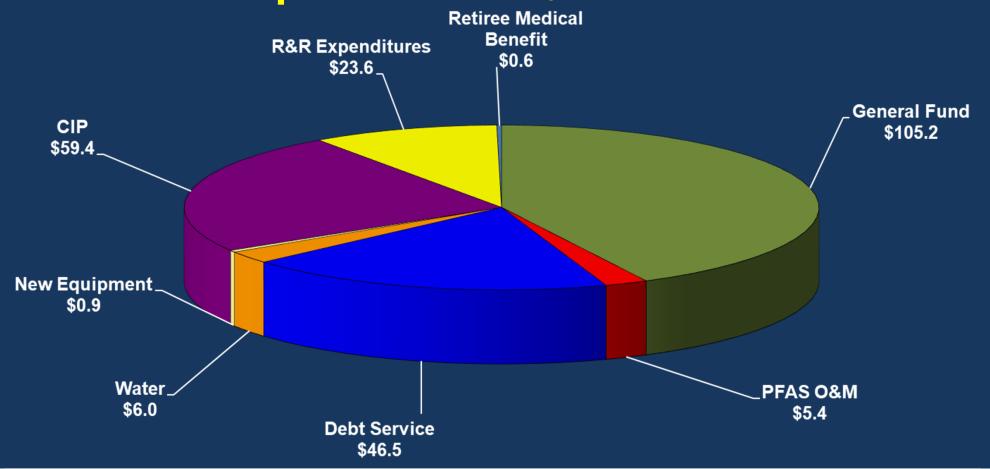

SUBJECT: USEPA PFAS DRINKING WATER REGULATIONS

SUMMARY

The U.S. Environmental Protection Agency (EPA) released its final National Primary Drinking Water Regulation (NPDWR) for per- and polyfluoroalkyl substances (PFAS) on April 10, 2024. It includes individual maximum contaminant levels (MCLs) of 4.0 parts per trillion (ppt) for PFOA and PFOS and 10 ppt for PFHxS, PFNA, and HFPO-DA (GenX), as well as Hazard Index comprised of multiple PFAS. Staff currently estimates approximately additional 40 Producer wells in the OCWD service would require treatment under the NPDWR and USEPA is allowing public water systems until 2029 to comply.

Per-and Polyfluoroalkyl Substances (PFAS) Response Program Policy Adopted November 20, 2019

Consistent with the Orange County Water District's mission and authority granted under the District Act and other provisions of law, it is the objective of this policy to provide guidance to the District in taking actions to protect the groundwater basin from PFAS compounds.

Orange County Water District policy principles are provided below:

- PFAS compounds create a unique groundwater contamination issue that impacts a large percentage of the Groundwater Producers. Without any action, PFAS impacted groundwater will continue to migrate affecting more wells and larger portions of the groundwater basin.
- OCWD desires to maintain a groundwater supply of suitable quality for all existing and potential beneficial uses. Quick and effective actions are needed to remove PFAS compounds down to established regulatory limits. Until treatment systems are constructed, the impacted Groundwater Producers will be purchasing greater amounts of more expensive imported water.
- OCWD will fund the lowest reasonable and efficient treatment system design and construction cost to remove PFAS compounds down to existing and anticipated new Response Levels and anticipated future Maximum Contaminant Levels.
- OCWD will provide a 50 percent subsidy for operation and maintenance expenses up to \$75/acre-foot. The exact amount of the O&M subsidy will be determined by OCWD with input from the Groundwater Producer after accounting for the specific circumstances of the treatment system constructed. It is fair and reasonable that the Producer should have some cost in addressing this potential problem. The \$75/acre-foot maximum is based upon current estimates

and knowledge of expected O&M cost. If unforeseen conditions are encountered or new information becomes available significantly increasing the overall expected O&M cost, staff will consider recommending a higher maximum amount to the Board.

- Spreading a large portion of the PFAS treatment cost over the entire basin conforms to OCWD policies of wanting Producers to have similar water supply cost.
- OCWD will not pay for temporary PFAS treatment facilities or for alternative imported water supplies.
- OCWD will review with the impacted Producers if the existing Basin Equity Assessment Exemption Program can be used to address their situation.
- OCWD will pursue grants and seek cost recovery from responsible parties.
- Producers seeking cost recovery for additional PFAS related expenses will be required to closely coordinate with the District and other impacted Groundwater Producers.
- This policy only applies to the nineteen Groundwater Producers.
